WILL DO:

- Male and Female Characters
 - Kemonomimis
- Original-Made or Fan-Made Characters
 - Fanart
- Suggestive/Mild Nudity
 - Mild Gore
- Light Armored Characters

WON'T DO:

- Heavy Armored Characters
- Muscular Characters
 - Heavy Gore
 - Mecha
 - NSFW
 - NFTs

ORDERING

- I have the right to reject your commission if I feel uncomfortable doing it or if I cannot execute it well.
- Please properly fill out the [Client and Character Commission Form](#) if you decide to order to avoid confusion and misunderstanding.

DELIVERY TIME

- Please be very patient when you decide to commission me. I work slowly due to my eye problem and I also have carpal tunnel syndrome.
- Please state if you want your commission to be rushed, as such you will need to provide an additional payment for it to be completed in your preferred time.
- Your commission piece/s will take 7-9 weeks or more depending on the complexity and type of commission.
- You can file for a refund if I do not give an update within 5 months.

PAYMENT

- I will only accept payments in **USD via PayPal**.
- I will only use the PayPal invoice to ensure the exact payment will be received.
- **Full payment or partial payment (50% front and 50% after the draft sketch)** must be given before I start on your commission.

REFUND

- **No unsolicited refund.**
- Full payment will be refunded if I am unable to complete your commission under any circumstances.
- There will be **no refund** once I have made the draft sketch of your commission.

CORRECTIONS AND REVISIONS

- Revisions of the draft sketch will only apply once I have received the full payment. You will only get **1 MAJOR REVISION** in the draft sketch (ex. Changing major pose and/or character).
- You will only get 5 minor revisions starting from the draft sketch until the final product of your commission. If your minor revisions exceed 5, an additional 2 USD must be given for every added minor revision.

PERMISSIONS AND COPYRIGHTS

FOR PERSONAL USE

- Commission piece/s is/are for **PERSONAL USE ONLY** and the client should not **REDISTRIBUTE, REPRODUCE, OR MAKE PROFIT** from the commissioned artwork/s.
- Clients **SHOULD NOT EDIT, TRACE, OR STEAL** the commissioned artworks. However, you can only edit the artwork **UNDER MY APPROVAL**.
- Clients can repost an artwork as long as **WITH CREDIT**.
- All commissioned artwork will be publicly uploaded to my accounts with credit to the original owner of the character unless told not to do so.

FOR COMMERCIAL USE

- I do not gain any royalties if this were to be used for commercial merchandising but it should always be with credit to the artist.
- The signature is removed.

(If you break any agreement within my terms of service during your commission process or after your commission is completed, I will permanently ban you from commissioning me again and will blacklist you in all of my accounts and name-dropped in all art groups.)
