  - Age Group Future Projects:
    - o Tri Championship meet with all 3 LSC's in New York State (sub-committee - Mike Cutler, Charlie Schutt, Phil Aronica, Nicholas Weiner) – Phil emailed age group chairs from Adirondack and received a response from Long Island. Long Island is open to the idea. We would like to host the first championship at ECC Burt Flickinger in 2024. Phil to reach back out to Adirondack.
    - Bus of select athletes to participate in a clinic at Indiana during Olympic
       Trials
      - (sub-committee Mike Cutler, Phil Aronica, Kaylee Maas, Nicholas Weiner, Charlie Schutt)
      - Below is what we discussed, but the committee chose to cancel the project because of NYS Final exams for HS. Phil received quote for \$12,000 for bus of 45 athletes, stay at Butler University. Criteria for athletes work from best represented athletes 13-18 we will charge athlete's families. Will need chaperones (5 coaches), \$500 per athlete was estimated, fundraising was discussed
      - A Niagara LSC gathering to watch Olympic Trials was proposed instead of a formal trip.
    - Quad Plan (2020-2024) discussed 10&Under Camp & Swim Biz Camp Eric and Marcia met with representative from USA swimming. Nicholas Weiner and Alec Wahl have given Eric and Marcia topics and criteria for the clinic. Discussed polling LSC athletes ages 13 and up on topics that they would like to learn more on such as swim data, technology behind swim meets, new Bills stadium technology. Also discussed bringing in a USA Swim Rep
