



# Printable Workbook Access: Terms of Use

Effective Date: March 1, 2026

## 1. License Overview

The Printable Workbook License provides access to printable student materials for a specific curriculum, organized by unit, for the purpose of printing and classroom use.

Each license covers **all teachers within one school building**.

This license is:

- Annual (time-limited)
- Non-transferable beyond the licensed teacher or physical school site
- Not valid for district-wide use in multiple buildings

Materials may be shared internally among eligible teachers at that school. The license does **not** extend to other schools within the district. Separate licenses must be purchased for each school site.

## 2. License Duration

Each Printable Workbook License is valid for a defined access period.

- Access granted **through May 31, 2027**
- Access will expire at the end of the stated term
- New licenses must be purchased for continued access in subsequent school years

The Comprehensible Classroom LLC reserves the right to update, relocate, or replace files annually as part of ongoing curriculum improvements.

## 3. Access & Delivery

- Licensed users will receive access to a **Google Drive folder** containing printable materials organized by unit

- Access is provided via a **view-only link**
- Materials may be updated, revised, or reorganized at any time during the license period

At the end of the license term:

- Access to the folder will be removed
- Continued access requires renewal

#### **4. Permitted Use**

Licensed users may:

- Print materials for use with their current students only
- Print materials unit by unit or as needed
- Use materials across multiple classes within the license scope

#### **5. Prohibited Use**

The following are strictly prohibited:

- Sharing the access link outside of the licensed teacher or school
- Uploading files to shared drives, team folders, or public platforms
- Distributing materials to other schools within or outside of the district
- Sharing materials with colleagues at other campuses
- Posting materials online in any way
- Retaining or using downloaded files **after the license expires**
- Selling, redistributing, or modifying materials for distribution

Each school building must have its own license. District-wide sharing is not permitted under this agreement.

#### **6. Intellectual Property**

All materials are the intellectual property of **The Comprehensible Classroom LLC**.

Purchase of this license grants **temporary access and use rights only**. Ownership of materials is not transferred.

#### **7. Updates & Revisions**

During the license period, materials may be:

- Updated for clarity, accuracy, or alignment

- Reorganized within the folder structure

The most current version of materials will be available in the shared folder during the active license term.

## **8. Printing Responsibility**

All printing is the responsibility of the licensed teacher or school.

The Comprehensible Classroom LLC:

- Does not provide printed materials under this license
- Is not responsible for printing costs, formatting adjustments, or local printing limitations

## **9. Renewal**

This license does not automatically renew. To maintain access, a new license must be purchased for each subsequent term.

## **10. Violations**

Unauthorized sharing or distribution of materials is a violation of this agreement and may result in:

- Immediate termination of access
- Revocation of license without refund
- Ineligibility for future purchases
