Dav The Duties of the Laity: An Open Letter to Fellow Laity of the Anglican Church in North America

Dear Fellow ACNA laity:

Our concerns align with the May 20, 2024 open letter to ACNA clergy, and we would like to invite the participation of our fellow ACNA laity. We suggest that the lack of transparency and clear communication regarding ecclesial disciplinary processes has limited our ability as laity to understand the deliberations of the church and to trust the procedures of the province to which we belong. We also are concerned for the well-being of survivors and other congregants who entrust themselves to the care of ACNA shepherds.

ACNA Canon I.10.2 outlines the duties of the laity and reminds us that "the effective ministry of the Church is the responsibility of the laity no less than it is the responsibility of Bishops and other Clergy." As members in the Anglican Church in North America, one of our canonical duties is "to observe [our] baptismal vows, to lead an upright and sober life, and not give scandal to the Church" (I.10.2.4) We regularly renew our baptismal vows and promise to "serve God faithfully in his one holy catholic and apostolic church" (BCP 194).

When someone is baptized, clergy and laity together extend this welcome:

We receive you into the fellowship of the Church. Confess the faith of Christ crucified, proclaim his resurrection, and share with us in the royal priesthood of all his people (BCP 190).

We believe that in order for the laity to faithfully serve the brothers and sisters we joyfully welcome into our midst, we must pay attention to matters in our province, dioceses, and parishes. As we work to build trustworthy communities, we can request transparency in our ecclesial processes, including the provincial response to handling of the situation in the Diocese of the Upper Midwest.

We as laity have the unique privilege to exercise our voice freely and make our concerns known to the College of Bishops, the Court for the Trial of a Bishop, the Provincial Tribunal, the forthcoming Archbishop elect, and other provincial officials. We know firsthand that informed and active laity are essential to the well-being of our parishes, but we want to draw attention to ways our participation in *diocesan* and *provincial* processes is essential to the soundness of our ecclesial structures. This includes

educating ourselves about our constitution and canons, praying for and participating in communal gatherings such as the upcoming <u>Provincial Assembly</u>, and paying attention to our trial courts and legal practices. Our active engagement not only contributes to the health of our own parishes but also reminds us that, as members of the province, we have a *right* and *responsibility* to be involved in provincial discussions.

Paying attention to the case in the Upper Midwest and the provincial response is part of what it means to participate in the growth and health of the unified Body of Christ (Eph 4). Furthermore, the matter of abuse warrants the ongoing attention of us all, because "if one part suffers, every part suffers with it; if one part is honored, every part rejoices with it. Now you are the body of Christ, and each one of you is a part of it (1 Cor 12, emphasis added)." Given this, we believe that asking our leaders for transparency in these matters is in accord with our baptismal promises and duties as laity in the ACNA.

Our concerns align with those of the open letter to clergy, and we quote at length from it below (modifications for laity bolded) with permission.

"Transparency Matter #1 The Progress of the Case

In July of 2021 the province, at the request of the Diocese of the Upper Midwest, took over the investigation into the handling of the abuse allegations (later proven in court) against Mark Rivera. Following the province's investigation, in late 2022, a majority of the <u>Provincial Investigative Team</u>, "recommended a presentment be considered against Bishop Ruch."

In December of 2022, three bishops signed a presentment against Bishop Ruch. This presentment was challenged as being canonically invalid by Bishop Ruch in January 2023.

This presentment and the challenge to it did not become public until June 2023. The challenge led to a canonical amendment also in June 2023 that allowed the case to proceed. In June of 2023, a second presentment was "submitted by priests and lay persons predominantly from within the <u>Diocese of the Upper Midwest</u>."

In August 2023, the Board of Inquiry made a "public declaration that, in the judgment of at least two-thirds of the Board of Inquiry, there is probable cause to present Bishop Stewart E. Ruch, III for trial for violations of Canon IV.2.3, Canon IV.2.4, and <u>Canon IV.2.9.</u>"

As it relates to transparency we note the following:

- (1) The Husch Blackwell report (the result of the provincial investigation) was posted in September of 2022 and removed from the provincial website a few days later. It has never been reposted and an explanation of its absence has yet to be given.
- (2) The recommendation of the Investigative Team was not made public in a timely manner.
- (3) The recommendation of the Bishops for presentment was not made public in a timely manner.
- (4) Bishop Ruch's challenge to the Bishop's presentment was not made public in a timely manner
- (5) Six months have passed since the last substantial public update.

There are no canonical prohibitions, as far as we can tell, from making these matters of public record.

In secular courts, case proceedings are often matters of public record. Ecclesial cases should not be held to a lower standard. This lack of information makes it difficult for laity to understand the matters at issue or to engage the process in ways that are helpful. Silence can instead fuel speculation, communicate a lack of concern to survivors and other congregants, and erode trust in our accountability structures.

Transparency Issue # 2: The matter of Inhibitions

According to our canons, inhibitions are not commentaries on the guilt or innocence of the accused. An inhibition is defined below:

"An Inhibition is a temporary suspension of a Presbyter or Deacon from the exercise of ministry, in whole or in part, when the Bishop believes that it is in the best interests of the accuser(s), the Church, and/or the accused to do so, pending an accusation, canonical investigation, presentment, trial or voluntary submission to discipline under these canons. An Inhibition may be used alone or in conjunction with a Godly Admonition (ACNA IV.2.12)"

There are three parties to weigh in an inhibition. What is in the best interests of (1) the accusers; (2) the accused; and/or (3) church. The process of inhibiting Bishops is outlined below:

"In the case of the presentment of a Bishop of this Church (including the Archbishop), three of the five senior active diocesan members of the College of Bishops by date of consecration (exclusive of any bishop involved in the presentment or trial) may, by their affirmative vote, temporarily inhibit the Bishop from the exercise of ministry. Such inhibition shall be in writing, signed by those consenting to it."

Given that the decision has been made *not to inhibit*, it appears that our five senior bishops have decided that it is not in the best interests of the church, the accused, and/or the accuser to inhibit Bishop Ruch.

A reasonable act of transparency would be to grant an explanation of why our leaders made this decision and its bearing on the accused, the accusers, and the church. This again is often the case in secular courts. Decisions are made and the rationale articulated.

Requests of our Bishops:

We humbly join our clergy to request the following:

- (1) Regular updates to the clergy **and laity** of the province and the survivors related to the progress of the trial in a spirit of transparency.
- (2) The creation of a timeline that allows us to know what to expect and when, alongside clarifications and explanations of any delays.
- (3) An update on the matter of the inhibition of Bishop Ruch and a clarification of the rationale of inhibitions more broadly.
- (4) Clearly outlined and accessible procedures by which laypeople can register documented concerns and questions."

The above statements outline the issues without attributing intentional malice to provincial actions nor do they presume the outcome of the trial. We as ACNA laity are also concerned about the potential harm done through this process, which has been publicly lamented by many of the survivors. We, too, believe that the church can and should do better and ask our lay and clergy delegates to address this at the 2024 Provincial Assembly.
