 - a. Article III, Section 1 of the Constitution gives Congress the authority to change the size of the Supreme Court. It has been done seven times before, and it can be done again.
 - b. Bring the Judiciary Act of 2021 to the floor in order to bring the size of the court from 9 to 13 justices to match the number of circuit courts.
- 4. We demand you fight for the investigation into Clarence Thomas' role in the January 6, 2021 coup.
- 5. We demand you fight for the investigation of Gorsuch, Alito, Barrett, and Kavanaugh's testimony on Roe during their confirmation hearings.
- 6. We demand that you advocate for policies that will actually reduce rates of abortion, such as universal healthcare, paid family leave, comprehensive sex education, free contraceptives, welfare funding, ending housing insecurity, closing the wage gap, and funding education.
