TUITION POLICY FOR ST. MICHAEL CATHOLIC SCHOOL

TUITION CATEGORIES:

Tuition for St. Michael Catholic School is determined by the following:

- Parishioner tuition rate will be granted to all St. Michael Parishioners who are active and registered prior to August 1, 2025 and have a current Stewardship form on file. If you joined St. Michael Parish after this date and wish to have your tuition status reviewed, you may submit a letter from your previous parish confirming your involvement in the giving of Time, Talent and Treasure.
- Parishioner tuition rate will be granted to all parishioners of parishes in the Archdiocese of Louisville that do NOT have a school, provided you are involved in giving of Time, Talent and Treasure. A letter confirming this participation must be submitted from your Parish.
- Non-parishioner tuition rate applies to St. Michael Parishioners who do not have a current Stewardship form on file.
- Tuition for all other families is the non-parishioner rate per child.

PAYMENT METHODS:

All St. Michael Catholic School tuition must be paid through an account with FACTS Tuition Management Systems. It is the responsibility of parents to establish the FACTS account for the current school year.

- Full Tuition Payment: Due August 1, 2026
- Semi-Annual Payments: Due August 1, 2026 and January 1, 2027
- Monthly Payments: Tuition and fees are divided into 10 equal payments from August, 2026 through May, 2027 and paid monthly via FACTS. For families of students enrolling in school after August 1, 2026, the monthly payment will be the total tuition and fees divided by the number of months remaining through May, 2026.
- Semi-Monthly Payments: Tuition and fees are divided into 20 equal payments from August, 2026 through May, 2027 and paid monthly via FACTS. For families of students enrolling in school after August 1, 2026, payments will be calculated based on the number of remaining installments through May, 2027.

PARTIAL YEAR ENROLLMENT:

Families are responsible for full payment of tuition for any month(s) their children attend.

NON-REFUNDABLE REGISTRATION FEE:

A non-refundable registration fee of \$150.00 per student is due at the time of registration and is applied to the total tuition bill. Additionally, FACTS charges a \$20.00 application fee which is also non-refundable.

SCHOLARSHIP ASSISTANCE:

Scholarship assistance is available for students in grades K-8. Families facing financial hardships are encouraged to apply for Scholarship Assistance funded by the Catholic Education Foundation (CEF) and St. Michael Catholic School. Confidential applications are processed by FACTS and can be accessed through the CEF website: www.CEFLou.org.

DELINQUENCY:

Failure to pay tuition or ancillary fees will result in the dismissal of the student(s). All tuition and fees must be current by the end of the school year in order to ensure the student's place for the following school year. Additionally, all fees must be paid in full for St. Michael Catholic School to transfer student records to another school.

St. Michael Catholic School reserves the right to pursue legal action for nonpayment of tuition and fees. The responsible party will be liable for all collection costs, including court expenses and reasonable attorney's fees. It is the family's responsibility to notify the Parish Business Manager of any changes to their preferred payment plan. Families who are two months behind on tuition payments, without prior arrangements, may face dismissal of their student(s).
