CEO Report & Facilities Report: Brian Ferguson

- · MYP is currently in great shape. Ms. Lepetit will continue to be in touch with the IB MYP consultants and receive a report on where our school stands in the authorization process. Ms. Patino is also in contact with the PYP consultants to wrap up the report which is due in end of June.
- · Currently ensuring that we are moving along for the SUNY renewal so that we can submit a flawless application. OWNCS hired a grant writer to assist our school with the IB authorization as well as the SUNY renewal.
- · Received a couple of grants Summer Boost Program from Bloomberg and 21st century grant. No communication has been sent out to the parents yet but will send out a notice this week informing them about the purpose of the Summer Boost Program (academic program for learning loss recovery). OWNCS will provide incentives for the middle school \$100 gift certificate if the child attends 90% of the time and raffling off a play station. The playstation raffle will only be for those who attend for at least 80%. Everyone is eligible for this summer program and OWNCS will be utilizing our own teachers to execute the curriculum. The program will be using an incentive model and children will be receiving points each day they are present so they can redeem their points for small prizes.
- · In June, eighth grade will be attending trips and many other grades will be planning field trips as well.
- Multicultural festival will take place in June.
- · OWNCS 3 have about 30 kids for the first grade A little behind but moving in the right direction and we have about 75 are enrolled in kindergarten.
- · Admissions team will be working with OWNCS 2 PTO to attract families with a carnival.
- · Gathering materials to send to Charter School Institute for the pre-visit at OWN 3.
- ·Will be using professional development funds for the admissions team They will be attending the National Charter School Conference in Washington DC so they can attend marketing workshops, etc.
- · OWNCS 1 ES has a long-term lease but must work with EDC to make some improvements to the building. OWNCS 1 MS is looking good now and is moving along well Planning to introduce the moving plan to the middle school families in the middle of the summer for SY 2023-24.
- · OWNCS 3- Looking into Plan B. We thought that we were on track with the construction since they were 75% done in April but looks like we will not have the building by the date we

expected. Therefore, we will be looking into the space at CQA until project is done. A meeting will be held to discuss all the logistics with the developers, and we will notify Ralph Rossi about our predicament. Project Completion will be by November 15^{th,} and we will receive the Certificate of Occupancy then.

CFO Report: Karrine Montaque

- · As of March 31, OWNCS had gross revenues of about 7 million- Pretty much on target. OWNCS expenditures 11.2 million so we are at loss of 224,000 since we are back in operation. From the COVID grants, we recognize 424,000 of that 11 million. The biggest part of those expenditures were Sylvan and tutoring services for the students, food services and contract/labor in the building, school supplies and Professional Development.
- · OWNCS 2- The gross revenues were 8 million. Expenditures were 5.5 million and income was 2.5 million. 2 million was from SBA. Although the numbers look great, we are pulling in 450,000 less than what we projected from the Per Pupil side.
- · OWNCS 3- Recognized 437,000 in expenses and the bulk of this expense had to do with shared and full-time salaries. Amounts have not yet been recognized but will look into CSP funding in the last quarter since a portion of the salaries can be charged to the grant.
