Using the application does not require any kind of registration or entry of any personal data.

Developers of Text On The Picture application (hereinafter referred to as application) collect from your devices only non-personal statistical data about the application, such as application failure reasons (failure log), device operational system version, mobile device model, type and brand, version of our application installed on your device, source of application installation, application launch time, language, device screen resolution, your gender, age group (without determining exact age), device Anonymized IP address to determine your country and city (without getting exact coordinates), etc. The application collects only performance statistics, such as the time a user spent on various screens; the backgrounds saving user statistics and ID of saved backgrounds. All data are presented in statistical form.

The data are non-personalized and are used by developers only to improve the application and fix bugs. Your country and city are determined only to help developers comply with laws and regulations of the country where you are staying.

Personalized information

When the application is running, developers collect some personal data from your devices such as Advertising ID , IP address, App-instance ID, device ID, etc.

The data collection is used to personalize the advertisement you see. Based on the obtained data advertiser networks will select and show the most relevant advertising.
