TOURNAMENT SPECIFIC INFO

1. All pool play results count, unless there is a forfeit, in which case all results of the forfeiting team are canceled.
2. Pool play in three team pools is 3 games to 21 points, each with 23 point cap. Pool play in four or five team pools is 2 games to 21 points with 23 point cap. Pool play in six or seven team pools is 2 games to 15 points each with 17 point cap.
3. Top two teams in pool play advance to Championship series with third and fourth place teams advancing to Consolation series. Fifth, sixth and seventh place teams in unmixed age division pools do not advance.
