Terms and Conditions

Introduction

Booking Policies

- **Reservations:** All bookings must be made in advance through our website or designated booking channels. Booking made and accepted directly to the stylist(s) of The Crystal Effect LLC are subject to all of the terms and conditions listed on this page.
- **Deposits:** Unless otherwise stated, or agreed upon, a deposit is required to secure a booking.
- **Cancellations & Refunds:** You may cancel your appointment up to 48 hours in advance. After the 48-hour mark, you may text to cancel at least 24 hours before your appointment. Cancellations made less than 24 hours before your appointment will be subject to a fee of 20% of the remaining balance. Any cancellations or cancellation requests made by the client are NOT subject to refunds.
- **Rescheduling:** You may reschedule your booking up to 48 hours in advance, subject to availability.
- **Service Eligibility:** Clients must ensure their hair is properly prepared before the appointment. Services may be declined due to issues such as, product such as oil or leave in conditioners on the hair and scalp, incorrect style selection, severely damaged hair, scalp conditions, or other health concerns.
- **Lateness Policy:** Clients arriving late may forfeit their appointment without refund. A grace period of up to 20 minutes may be provided at the discretion of The Crystal Effect LLC.
- **Client Responsibility:** Clients must voice any concerns or dissatisfaction before making payment and leaving the establishment. Once payment is made for services, no adjustments or refunds will be issued.
- **Post-Service Adjustments:** Once services have been rendered and the client has left the establishment, The Crystal Effect LLC reserves the right to deny any adjustments to the style unless the concern was raised before payment was made. If an adjustment is agreed upon after the service date, it will only be accommodated based on schedule availability during regular business hours.
