

Inspire Life Design Beta Experience

Participation and Coaching Agreement

This Participation and Coaching Agreement (the "Agreement") is between Ranise Gillespie LLC ("Coach") and the person enrolling in the Inspire Life Design Beta Experience ("Participant"). The Agreement becomes effective when Participant checks the consent box and completes enrollment electronically.

1. The Beta Experience

The Inspire Life Design Beta Experience is a six-week, Bible-based coaching and spiritual-growth experience. It uses Scripture, prayer, reflection, and coaching exercises to help Participant examine an area of life, hear from God, identify a Desired Outcome, and participate with the Holy Spirit in heart transformation and the renewal of the mind.

The \$27 enrollment fee includes:

- Six Sunday teaching, prayer, and group-coaching sessions from October 4 through November 8, 2026, from 7:00 to 8:30 p.m. Eastern Time.
- Five Wednesday prayer and question sessions from October 7 through November 4, 2026, from 7:00 to 8:00 a.m. Eastern Time.
- Daily prompts, session recordings, the private Beta community, the 815 Companion App or downloadable exercise PDFs, and the digital 90-Day Planner and Journal.
- Access to the private Beta community, recordings, and posted materials through May 8, 2027.

Attendance is encouraged, and there is no minimum attendance requirement. Missed group sessions will not be rescheduled individually. Participant agrees to complete the weekly feedback forms and final evaluation requested as part of the Beta Experience.

2. Coaching Relationship and Participant Responsibility

Coaching is a collaborative process designed to support awareness, spiritual and personal growth, decision-making, and action. Participant is responsible for her well-being, choices, actions, and results, including how she applies anything discussed or provided through the Beta Experience.

The Beta Experience does not provide medical care, mental-health treatment, trauma treatment, legal advice, or financial advice. Participant is responsible for seeking qualified professional care or advice when needed.

3. Payment and Refunds

The enrollment fee is \$27 and is paid in full at registration. The Coach will personally review enrollments. If the Coach determines that Participant is not a suitable fit for the Beta Experience, the Coach may cancel the enrollment and issue a full refund. If the Coach cancels the Beta Experience, Participant will receive a full refund. All other sales are final once program access has been provided.

4. Recordings and Group Confidentiality

The Sunday sessions and Wednesday prayer and question sessions will be recorded. Participant's name, image, voice, chat messages, and comments may appear when she participates. By accepting this Agreement, Participant consents to these recordings and to their availability within the private Beta community through May 8, 2027.

Participant agrees to respect the privacy of the group and refrain from recording, photographing, copying, or sharing another participant's identity, story, comments, or personal information. The Coach will treat information shared by Participant as confidential, subject to disclosure required by law or reasonably necessary when there is an imminent risk of harm to Participant or another person. Because this is a group experience, the Coach cannot guarantee the conduct of every participant.

5. Digital Privacy

Responses entered into the 815 Companion App and optional cleansing exercise are saved locally in the browser on the computer or device Participant uses. The responses are not connected to a personal app account, transmitted to the Coach, or stored in an external response database. Participant must use the same browser and device to return to saved work. Clearing browser data, using private browsing, changing browsers, or changing devices may remove or prevent access to saved responses.

Participant is responsible for protecting downloaded files, locally saved responses, passwords, and devices. Third-party services used for payment, email, text reminders, video conferencing, community access, and course delivery process information under their own terms and privacy practices.

6. Communications

By enrolling and providing contact information, Participant agrees to receive program-related emails and text-message reminders, including access instructions, schedule reminders, session links, and program updates. Message and data rates may apply. Participant may opt out of text messages by replying STOP where supported.

Participant will also be added to Ranise Gillespie's weekly email list and may receive information about teachings, resources, programs, and offers. Marketing emails will include an unsubscribe option.

7. Program Materials

All lessons, recordings, worksheets, PDFs, prompts, journals, frameworks, app content, and related materials remain the intellectual property of Ranise Gillespie LLC and its licensors. Participant may download and print provided materials for personal use. Participant may not sell, publish, distribute, teach, reproduce for commercial use, share access credentials, or forward the materials to another person.

8. Withdrawal and Removal

Participant may withdraw at any time. The Coach may end Participant's access for conduct that materially disrupts the group, threatens safety, breaches confidentiality, infringes intellectual property, misuses technology, or violates this Agreement. Refunds following withdrawal or removal are governed by Section 3.

9. No Guarantee and Limitation of Liability

The Coach makes no guarantee of a specific spiritual, personal, relational, health, financial, vocational, or business outcome. To the fullest extent permitted by law, the Coach and Ranise Gillespie LLC will not be liable for indirect, incidental, consequential, exemplary, or special damages arising from the Beta Experience. Total liability under this Agreement will not exceed the \$27 paid by Participant. This limitation applies only to the extent permitted by law.

10. General Terms

This Agreement and the terms presented at checkout reflect the complete agreement between the parties concerning the Beta Experience. Changes must be made in writing. If any provision is held

invalid or unenforceable, the remaining provisions will continue in effect. This Agreement is governed by the laws of the State of Florida.
