New Business

8. Funding request for an artist in residency

- looking at DanceEd dancED Inc. joy, growth & connection through dance
- Dance ED is well known, one of the most sought after artist in residencies in Edmonton, they are expensive but they are GOOD at what they do
- Kyril advised that they are very experienced, they know what they do and they know it well they really know how to include kids with special needs and are very inclusive.

 This is a residency within the curriculum fine arts related in the PE curriculum.

At the end of the program, there is a showcase – essentially a dance concert

- we would be looking at 19 days for a school our size
- cost is \$20k /year and are looking for 2 year commitment \$40,000 total, looking for PA assistance for half the cost, which is \$20k.
- feel 2 years is needed to show the kids growth.

also asking for a 2 year commitment because the first year is a lot of transition and getting the kids into it and getting the kids comfortable taking risks with this.

Kyril has seen incredible growth and development in kids with this program.

Need an answer on this sooner rather than later since Kyril needs to go to budget mid April. We will need to vote on this next meeting.

Kyril can also get parent or kid testimonials if we need.

In regards to what type of dance/music: DanceEd will suggest safer music/dance options to start, but they will also talk to the kids and see what they are into and what music or dance style they like and then the next year(s) they will take the student input into consideration and suggest a different, possibly more risky type.
