

Avoid unusual abbreviations and define all symbols used in the abstract. Using keywords related to the research topic is recommended.

(SUB TITLE Center, Bold, Times New Roman 13, UPPER CASE, After 6 pt, Before 18 pt)

Articles are made into 1 column pages with A4 paper size. For Top Margin 3 cm, Left Margin 3 cm, Bottom Margin 1.5 cm, and Right Margin 2 cm. Manuscripts created using Microsoft Word, single spacing, 10 pt Times New Roman, and no more than 10-13 pages.

Please select the article title (maximum 14 words) with the fewest possible words needed to adequately describe the content. In the title avoid the word design, and it looks like the problems and application methods that will be discussed in the discussion chapter. The introduction must describe the background of the research, it must show the research background (state of the art), related/similar research (at least 5) by stating what the difference is with your research. In the introduction, the solution/objective of the research should be seen. if in the article there is a citation, must use [1], [2] and so on using the Mendeley citation tool with the IEEE format. Terms in foreign languages are written in italics. In the first paragraph, describe what is the problem in the research (in the form of a paragraph description), also describe what is expected to be a solution to the problem in your research. Next, describe related research that is similar to your research (at least 5) with an update 5 years before, so that with this related research it can bring up a GAP Analysis of the research you are doing. At the end of the introduction, describe the objectives of your research and what you hope to achieve from your research.

It is suggested for the author to use the following article structure: INTRODUCTION (min 700 words), RESEARCH METHODOLOGY (min 500 words), RESULTS AND DISCUSSION (min 1800 words), CONCLUSION (min 200 words). Maximum article contains 10-13 pages.

2. RESEARCH METHODOLOGY


2.2 Sub Title 2 (After 6 pt, Before 6 pt)
