* Early Risers operates on a fixed schedule like After School. Families choose a weekly schedule, children may only attend on the mornings enrolled, and monthly tuition will be charged in advance, regardless of attendance. The rate includes a per morning discount for those who enroll for 3, 4, or 5 days.

All tuition and fees are per child.

Deposit and Registration Fee

New families must pay a deposit (\$200/family) when their enrollment is confirmed. Re-enrolling families will be billed for a new deposit in March to reserve their space for the following year.

New families must pay a registration fee (\$25/one child, \$40/two or more children). Re-enrolling families need not pay another registration fee unless they are registering an additional child (\$25).

Reduction in the number of days a child attends ASAP or withdrawing from the program before the end of the school year will result in forfeiture of the deposit. If the current year's deposit remains in an account in May, it will be applied as a credit on the June invoice.

After School

Early Risers and After school tuition is calculated based on the number of "full days" in the school year, divided by the 10-month school year calendar. Early release and vacation days are not included and are billed separately.

Early Release Days

On early release days, we provide a pizza lunch and a movie, performer, special activity or field trip. If you are enrolled for a day of the week on which there is an Early Release Day, you will be automatically signed up and billed unless you provide one week's notice that you do not need care. Families not already enrolled for that day of the week will be able to sign up on a first-come, first-served, space-available basis.

Vacation Program

We are open Tuesday through Thursday of February and April vacation weeks. These full-day programs include special guests and/or field trips. Families are notified via email when registration opens for each of these days.

Financial Assistance

The Financial Assistance Program of the Natick Public Schools opens in April. All applications and the required documentation must be submitted to the NPS Business Office (not the ASAP office). This program covers assistance with the following program fees: ASAP/Early Risers, Laptop Program (Grades 8 and up), Interscholastic Athletic Fees (Middle and High School) and Musical Instrument Lessons (Grades 4 and up). PLEASE NOTE

- Invoices are emailed on the 1st of the month. Payment is due on the 20th. Each invoice includes the before and after school tuition for the next and any early release or vacation day charges for the previous month. (Example: The October 1 invoice will include the November Early Risers and After School tuition and any September early release or vacation day charges. Payment for all will be due on October 20).
- ASAP accepts checks and money orders by mail and electronic checks and credit card payments through the Natick Public Schools website, www.natickps.org. We strongly encourage payment online. The fee for online check payments is \$.25.
- No tuition credit or trade days will be given for absences, school closings, or any after school activities outside of ASAP that a child attends.
