Student Device Instructions- For Grades 9-12

STUDENTS WILL NOT BE ALLOWED TO BRING THEIR OWN LAPTOP/TABLET!!!!!

<u>Student and Parent</u>: READ and SIGN "Device Guidelines and Agreement". Turn into the office.

Your device MUST be in a case or backpack when you carry it home.

You will turn the device back into the school at the end of the year, with the account information page. At that time, you will complete an "End of Year Device Check-in".

Take the device home and fully charge (up to approximately 5 hours). It is your RESPONSIBILITY to make sure the device is charged and ready for school each day.

You have Google and Office 365 accounts. If you forget your password, I can reset it for you.

Per your "Agreement", you can only install programs approved by the district. Any student caught Powerwashing their Chromebook and re-enrolling it as a personal device WILL lose device privileges!!

Remember, if you install something that damages your device, or makes it unusable, the device will be restored to factory settings, and you will lose anything not saved. Save often to your GoogleDrive.

You are responsible for keeping/replacing the charger, charging cord. The current cost to replace these items are as follows:1) AC adapter - \$20, 2) Dell Laptop - \$1,200 <u>DEVICES with STICKERS on them will invoke a \$20 fee!</u> (Take the stickers off before you turn your device in.)

Munday CISD Device Acceptable Use Agreement Learning in the Present; Preparing for the Future

Munday CISD is pleased and proud to offer our staff and students Laptop devices and the Internet. Use of the wireless network will provide MCISD campuses access to numerous software programs and the Internet for educational purposes. Munday CISD believes that teaching using 21st Century tools will improve the educational opportunities for our students.

Internet connection at home will be beneficial to students. This information will be provided to parents. The device will have many uses at home without Internet Access, but the students' ability to get full benefit from their assigned device will be much greater if they have Internet access.

We hope that you share our excitement of being able to offer the devices as an instructional resource to our students and teachers at MCISD. The impact on teaching and learning will be enormous. Our students will gain access to up to date information and will be able to use this information to enhance learning. In addition, their technology skills will increase and better prepare them for higher education and the workforce. As with any new initiative, there will be constant assessment and necessary changes to make this project work to the maximum benefit of our students. We are committed to that goal.

This Agreement represents an outline of the Device Policies and Procedures. By signing this Agreement, students and parents/guardians agree to follow the Policies and Procedures. Students and parents/guardians are encouraged to read and understand these Policies and Procedures prior to signing this Agreement.

Access to the Munday CISD devices and systems is a **privilege**, **not a right**. Violating the letter or spirit of the regulations may be cause to deny a student access to the Munday CISD devices and systems, and/or may result in more serious disciplinary action(s) and/or financial obligations.

Responsibilities of Stakeholders:

General Care of the devices

- Treat the device with care by not dropping it, getting it wet, leaving it outdoors, or using it with food or drink nearby
- If the device is damaged or not working properly, it must be turned in to the Tech Office for repair or replacement. Parents/guardians and students are not authorized to attempt repairs themselves, or contract with any other individual or business for the repair of the device.
- Keep your device closed when transporting it and inside your approved case or backpack. If repeated abuse occurs, device privileges will be revoked.
- Do not leave your device in an unsecured area. This includes an unlocked locker/locker room.
- Do not loan the device to anyone.
- Protect the device by unplugging the power supply and other peripherals when transporting the device.
- Protect the display by carefully closing the lid when moving the device (if applicable).
- When transporting their device to and from school, students should always be sure it is placed in the carrying case, and the case is fully closed. Students are expected to treat their device with care and respect. The device and hard case are the property of Munday CISD, and should be kept clean and free of marks at all times. Placing stickers, writing or drawing on, engraving or otherwise defacing the device or carrying case are not allowed and will result in loss of privileges and disciplinary consequences.

- Students should not use their device while walking, on the bus, or otherwise being transported. devices should only be used while they are on a flat, stable surface such as a table. devices can be fragile, and if they are dropped they may break.
- Students should protect their device from extreme heat or cold. devices should never be left in a car, even if the car is locked.
- Computers should be protected from the weather, water or other liquid, food, and pets. Students should never eat or drink while using their device, or use their device near others who are eating and drinking.
- Heavy objects should never be placed or stacked on top of your device. This includes books, musical instruments, sports equipment, etc.
- Students should use care when plugging in their power cord.
- Computers should never be placed in their carrying case while they are turned on. The device should either be turned off or in "sleep" mode. In addition, devices should not be placed on or under soft items such as pillows, chairs or sofa cushions, or blankets. This will cause the device to overheat, and will result in damage to the device.

General Use of the devices and the MCISD Network System

- Munday CISD fully expects that all members of the school community will use the device systems
 in a responsible, appropriate, and legal manner. Use the following regulations as a guide when
 working within our devices or device system:
- Follow the Munday CISD Acceptable Use Policy when using the Internet at home or at school.
- Any inappropriate or careless use of a device should be reported to a teacher or other staff member immediately.
- Students must immediately report theft or damage to a teacher or administrator. For hardware and software problems, students must take their device to the technology office, or contact Ms. Bowman (Kim.Bowman@mundaycisd.net)..
- Do not load software from the Internet unless you have permission from a MCISD teacher.
- Do not remove programs or files from the device. Any student caught

 Powerwashing their Chromebook and re-enrolling it as a personal device WILL lose device privileges!!
- Honor your family's values when using the Internet. Parents will discuss family values and expectations regarding the use of the Internet at home. Parents will supervise their child's use of the device at home.
- Do not give personal information when using the Internet.
- The school's Internet connection should be used only for research or information gathering that is
 directly related to academic assignments or extracurricular projects supervised by the MCISD
 faculty.
- During school hours, game playing on devices is not allowed unless the game is directly related to a school assignment or activity.
- E-mail (or any other device communication) should be used only for legitimate and responsible communication between students, faculty, and the outside world. Rude, abusive, threatening, or otherwise inappropriate language is not permitted.
- Students may access only those files that belong to them or which they are certain they have permission to use. Students are expected to follow all copyright laws.
- Files stored within the school device systems (both device and file servers) should be limited to those relating to formal school courses or activities. Games, commercial software, or graphic files that are not for a school project or formal activity should not be stored on the school device systems.
- Students are expected to only access teacher authorized sites at the appropriate times.
- Students are expected to notify their teacher immediately if they accidentally access an inappropriate site.
- Students may only use their assigned network drive or cloud drive to store school related files only.
- Students should always protect their user account by logging off when not on their device.

- Each device is assigned to an individual student. Students should never "swap" or "share" their device with another student. devices should be in a student's possession or secured at all times.
- Students may never share their password with another student. Passwords should always be kept confidential.
- Students are responsible for saving or backing up their documents to the server.
- Students should never attempt to "Hack" into any device system or engage in unauthorized use of the network.
- All users must agree to never maliciously damage or steal school device equipment or electronic data.
- All users must agree to never change the settings of school-supplied software.
- If the device is stolen while at home, parents/guardians should immediately report the theft to the local police. This information should also be conveyed to the campus principal at the first opportunity available.
- The students may only use the email account that is set up by MCISD.

Daily Preparation Tasks

- Recharge the device battery every night.
- Bring the device to school everyday and have it ready to work at the beginning of each class.
- If a student fails to bring their fully charged device to school each day, consequences outlined in the student code of conduct will be applied.
- Students who do not have permission to take their device home may pick up their device in the
 designated area each morning, and are required to return their device to the designated area at the
 end of each day.
- Students will be allowed to recharge their devices each day during classes that are conducive to this. Very few classes will have this capability, so avoid any potential problems by charging them each night at home.

Using the Computer for Internet and E-mail

- Students and parents/guardians understand that Munday CISD does not have control over
 information found on the Internet. While every attempt is made to block access from inappropriate
 material while the student is at school, the district is not able to monitor student usage of the
 device while at home. It is the parent/guardian's responsibility to supervise the information
 that a student is accessing from the Internet while at home.
- Students should be aware that Internet access and e-mail, and other media that are accessed, created or stored on their devices are the sole property of the District. The District has the right to review these items for appropriateness, and to limit or revoke a student's access to them at any time, and for any reason.

Consequences of Inappropriate Use

The use of any district technology is a privilege and not a right. Students are expected to use their device in accordance with these Policies and Procedures, and District Acceptable Use Policy and any applicable laws. Failure to use this device in an appropriate manner will result in consequences, as determined by the staff and administration of Munday Consolidated Independent School District.

Students who leave the District and fail to check in their devices and related equipment will have felony theft charges filed against them immediately upon the District's knowledge of such an event. The District will prosecute the occurrence to the fullest extent of the law.
