SBIRT

Screening, Brief Intervention, and Referral to Treatment (SBIRT) focuses on prevention, early detection, risk assessment, brief counseling and referral for assessment that can be utilized in the school setting. Use of a validated screening tool will enable school health teams to detect risk for substance use related problems and brief intervention strategies will help to address these concerns at an early stage in adolescents.

Legislation Mandating SBIRT in Schools

In March, 2016, the Massachusetts Legislature enacted an Act relative to substance use, treatment, education and prevention (STEP Act) which outlines the requirements for public schools in the Commonwealth to engage in substance use screening and education. IHR has been dedicated to fostering a family centered, trauma-informed strengths-based approach to treatment, based on nurturing relationships between clients and clinicians.

IHR is a CARF-accredited, licensed mental health and substance abuse clinic offering the following services:

- Individual outpatient treatment for adults, youth and families struggling with substance use, trauma and/or mental health issues
- Walk-in services, no appointment necessary, 9am-5pm, Monday-Friday (Cambridge office only)
- Recovery and wellness groups, especially for young and adult women

IHR provides treatment in client homes and other community locations and at their Boston, Cambridge or Lowell offices. These offices serve greater Boston and all of northeast Massachusetts.

Massachusetts Department of Public Health Bureau of Substance Abuse Services

The Bureau of Substance Abuse Services (BSAS) oversees the substance abuse and gambling prevention and treatment services in the Commonwealth. Responsibilities include: licensing programs and counselors; funding and monitoring prevention and treatment services; providing access to treatment for the indigent and uninsured; developing and implementing policies and programs; and tracking substance abuse trends in the state.
