All of the sources above are imaginary and the links are invalid, except for *Wikipedia*. The **bold** font is used only to point out key elements. In APA style, you don't use bold font except for special purposes, such as in some headings.

How to get APA references, and create in-text citations

1. Create a reference for the source in APA style (7th edition).

- Start with the automatic APA reference given in **MegaSearch** or another library database. You can email this to yourself.
- Double-check these elements
 - The article title should be in sentence case (mostly lower case).
 - o Author names should give the first name and the middle name (if given) as initials: Smith, B. T.
 - If a name is in ALL CAPS, you need to correct this.

• Example for a journal article

Recipe for a journal article

Author, A. A. (Year). The article title is capitalized like this: Mostly lower case. The Journal Name Is Like This Vol#(Issue#), page-page. Insert a live link using the article's DOI

• Optional: replace the **DOI** with the *permalink* from MegaSearch. This will let you return to the article easily. The official APA style says to use DOIs, but for student papers permalinks will be more useful. Ask your instructor.

2. Accurately paraphrase the source, then insert an in-text citation.

- Use one of these styles:
 - Narrative citation: this is written as part of your text. Usually, it introduces your paraphrase
 - Parenthetical citation: the citation is contained in parentheses. Normally, it follows your paraphrase.
- Count the number of personal authors in the reference. Then find an example in the table above, for one, two, or three or more authors. Add the publication year. (Give the year only, not the month or day.)

3. Pay attention to the details in the in-text citation.

- Notice where the **periods** and **commas** belong.
- Notice "and" vs. "&"
- The author's initials are not used in in-text citations (except for special situations).
