### **Approval of Minutes**

#### **Discussion:**

Presentation by Rosangela Berbert Executive Director of Samaritan Counseling Center of the Fox Valley, Inc.: Samaritan Counseling Center is a nonprofit mental health services agency. Founded in 1970 by First Congregational UCC, Appleton. They connect mind and spirit so individuals, families, organizations and communities thrive. In 2017, Samaritan counseled 1200 clients with 200 + residing in Oshkosh. They will offer wellness screening for over 12,000 K-12 students in 2017-18. Serves 10 school districts. Also provide Mental Health Ministry Initiative -meeting mental health needs via faith communities. This equips faith leaders as mental health first responders. Samaritan has 5 locations throughout the Fox Valley: Oshkosh, Menasha, New London, Kaukauna, and UW-Fox Valley. El Centro de Esperanza (currently only available in Menasha and Kaukauna) serves Spanish speaking families with education for individuals and families, support groups for women and teens, and counseling for children and adults. They do not have any interpreters at this time due to the high cost. They use a sliding fee if families have difficulty paying. Lowest charge would be \$20/session. Current cost for an intake apt is \$185/session and following sessions are \$130. They take most insurances and badgercare. Need: Looking for funding to assist homeless population. Sometimes they have to put a cap on how many adults served. If Samaritan cannot serve a client, they will assist clients to find a counselor by utilizing the myconnectionnew.org website.

**Winnebago County/Oshkosh Housing Authority:** Kay handed out the Family Self Sufficiency December newsletter. WCHA/OHA is working with a family to buy the property at: 1628 Elmwood Oshkosh. 902 W 4th St home is done with rehab and will be on the market soon. The Habitat home on the corner of Parkway and Grove is completed.

**Day By Day:** Day by Day is in need of Fast food gift cards. They are giving them to people that are turned away. People are lining up at 12 noon. They are at capacity every night. Giving Tuesday raised \$30,000.
