privacy -- Personal modesty. “(3) An LEA may not require, invite, or encourage a student to undress, change clothing, or otherwise be in a state of full or partial nudity in the presence of another individual. (4) (a) An LEA is presumed to comply with Subsection (3) if the LEA ensures the availability of the following for students who choose to undress or change clothing in private: (i) single-occupant facilities; (ii) floor-to-ceiling walls and doors or similar privacy protections within changing facilities; or (iii) curtains or similar privacy protections in changing facilities.


