Use the Gill Sans MT font in 11 size for abstract.

Keywords: There are about 2-5 keywords; Separated by semicolon (;) between keyword

1. Introduction

The author should provide the background problems of the research based on literature review. The objectives of the research should be stated along with the originality of the work (state of the art). The cited articles should be written in order by year of publication, for example, (Creswell, 2022; Putro, 2021; Aitbayev, 2017). Citations are written in IEEE style by Mendeley application which are shown as [1,2,3]. Use the Gill Sans MT Font in 12 size. The paper length should be up to 13 pages or about 5000 words.

2. Methods

Explain detail methods effectively which show the originality from the author. The methods should be written clearly so that the work can be reproduced. If the methods have already published, author must write the reference and describe the modifications.

2.1. Equation Formulae

The formulae should be written in the text, centered and followed by consecutive number as Equation 1, Equation 2, and so on.

The example of formulae can be seen below (see equation 1).

$$V = \frac{4}{3}\pi r^3 \quad (1)$$

where V is the volume of sphere, π is the coefficient of circle, r is radius of a circle.

4. Conclusions

The conclusions present the remarkable findings and contribution of the research to the relatable field. The conclusion section must not repeat the results in the previous section. This section should summarize the notable outcome.

Inform the individuals or institutions who gave contribution to this research. The participation of other institution or person can be in the form of providing grants, laboratory facility, equipment assistance, etc). Especially for the grants, please provide the number of grant decree and year of the grant received.

The minimum number of references is 15 written in the IEEE style which show the number and bracket. The citation style can be found in the Mendeley that the author is recommended to use the application. The references should be accessible sources and the citation given in the text should match in the reference list. Several citations should be arranged by the publication year of the sources.
