  - 7.1) President Jackson: Hello everyone! My Presidency has been in full swing and I'm excited to share with you all I've been working on and with so far. I had my first meeting with UDAC in hopes of bridging our USG to regional campuses' USG. I also was able to meet with the soon-to-be-announced BUS President going over what our roles will look like working together moving forward. I have been assisting the LGBTQ+ Center's GA and intern with a student-led initiative to take place soon. The ARTF had our final public report out and committee-chair meeting, thus I have submitted my name as interest in continuing on the DEI task force to implement the recommendations into action. And I am working with SRVSS to assist in locating funds received from the Ohio Department of Edu for efforts to combat sexual violence on campus. As for USG internally, I've conducted interviews to fulfill the rest of our Senate. I've also been helping with the interview process and sitting in those interviews for both Director Dube's Allocations Committee and Director Fermaintt's Programming Board. I've had a few 1:1's with USG representatives and really sending out emails to USG representatives/my colleagues and organizing behind the scenes to assure us as a unit are moving on track! I'm proud of us, keep being great.
  - 7.2) **Director Allen:** Hello everyone,

I hope all is well. Thus far I have done a few things including:

- Participated in the interview process with President Jackson and my fellow Directors for the appointed positions.

- I reviewed my notes from my meeting with my predecessor, Senator Reilly, and I have started multiple tasks based on what she and I discussed.
- As Senator Reilly and I discussed, building a strong committee for COBA is instrumental in gathering student opinions and ideas. I created an application for the College of Business Administration Committee via Google Forms and will be distributing this soon.
- I met with Dean Elizabeth Sinclair of the College of Business Administration after our class. Senator Reilly mentioned that she was a huge asset during her term and that establishing communication with her would be beneficial to my success in this position.
- Dean Sinclair and I discussed Business Professionals Roundtable as a way to stay updated on current events in the College of Business Administration. I've made plans to attend their meetings in the Fall.
- 7.12) **Senator Dubensky** (doo-ben-ski): I have begun the process of establishing a committee of nursing students as recommended by my predecessor in order to develop a consistent group of dedicated individuals to gain insight from regarding the needs of the students comprising the College of Nursing. I plan to reach out to Senator Espersen again to gather more insight on the best ways to go about leading this committee. I have been asked to sit in on presentations from the three candidates for the Dean for the College of Nursing this coming week. I will be attending these on Monday, Tuesday, and Wednesday in order to provide my input as to who would be best fit to serve in the position from the perspective of a current student. Additionally, I plan to reach out to the Period Project in order to connect with them as Senator Espersen worked with them and spoke highly of the experience. I believe their work is vital for students at Kent State and want to aid them by involving myself in their efforts.
- 7.13) **Senator Dum:** Hope things are going well. I've begun planning for fall 2022 and events that can be hosted for the students in the College of Public Health. I plan to have as many students as possible to get CPR and first aid trained. I plan to begin planning a budget for the 2021-2022 school year and have a framework for the upcoming year. Finally, I will begin to email the supervisors of different student organizations to get a head start on planning for the following year.

- 7.16) **Senator Maller:** Hello everyone! After speaking with Director Dingey and Senator Cline there are a few things that I would like to implement this upcoming year. First of all , Director Dingey spoke on a program where I would speak with all of the clubs within my college to see if they would benefit from additional funding and from there I would set up a program so that if a certain percent or number of their members volunteered at a local organization they would receive that extra funding. I tend to favor this program because it not only supports our Kent community but also connects us with our community so they can learn and ask questions to better understand our college and its clubs. I would also love to potentially work together on this program with other College Senators. A program that I am still trying to solidify, as recommended by Senator Cline, is one in which narrows the gap between our aeronautics students and engineering students. I also spoke in the debate about the current restrictions on tutoring through our college, which I am planning to speak on during a future meeting in my college to see what options are available.
- 7.17) **Senator Walton**: Happy Wednesday Everyone! On Monday the 12th, I met with my predecessor, Diana Chang to discuss future programs and legislation ideas. After the meeting, I created an agenda term list for future legislation, ideas, and projects that I want to fulfill. I reached out to the contact list she gave me including Dean

Munro-Stasiuk, Meghan Factor-Page, Dr. Hylton, Craig Berger (who helps with civic engagement), Dr. Taela Drummer-Ferrell, and (Ohio CEEP Director) Nate Hall. Within this meeting I had the opportunity to meet with Director Niepsuj to discuss the reality of these goals, and time management. We discussed mental health, time commitments to my position, and how to avoid burnout. I would highly suggest informational interviews with campus administrators and investigating services and resources that are in place for students at this time. Prior to you beginning projects you will want to investigate what is in place and where the actual gaps are. This sweet spot is where you might find you will be the most successful. Just because you haven't used or heard of a service, doesn't mean it doesn't exist. You may find that if you didn't hear about it or use it that you might be able to assist getting the word out to students.

Please be prepared to talk about budget in the July meeting. You may also need to approve some summer allocations since the allocations board isn't in place just yet. There are very specific policies and procedures we must adhere to to spend money. I will be happy to assist you with this and will be working with Taksh to come up with funding request procedures. In the meantime, know that the funding and payment process takes time- so be prepared to plan ahead a month in most circumstances. FOr programming, Alice and I will work on a 3 month in-advance contracting plan.

Plan to attend August training, my analogy for not having you present as part of the team is like trying to drive on a flat tire. When people are missing it hinders our success.

Hearing about your ideas has been energizing! I am looking forward to working with you.
