- a) Meteer is a directional customized robot controller APP. No registration is required, and you can turn on Bluetooth to control the robot to achieve set actions, expression display, and WiFi network configuration. The personal information in your mobile terminal that may be used includes but is not limited to (mobile phone device information, Bluetooth ID, local music list on the phone...)
- b) User personal data obtained by Meteer through legal channels.
- 2. Information usage
- a) Meteer will not provide, sell, rent, share or trade your personal information to any unrelated third party.
- b) Meteer also does not allow any third party to collect, edit, sell or freely disseminate your personal information by any means. If any Meteer platform user engages in the above activities, once discovered, Meteer has the right to immediately terminate the service agreement with the user.
