

Dear Parents and Community Members:



The AER is available for you to review electronically by visiting the following web site: Pleasant Ridge Elementary School AER, or you may review a copy in the main office at your child's school.

For the 2024-25 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2023-24. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2023-24. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2023-24. Some schools are not identified with any of these labels. In these cases, no label is given. Pleasant Ridge Elementary has NOT been given one of these labels.

In combination with home to school communication, support for social emotional wellness and regular benchmarking, Pleasant Ridge Elementary implements literacy interventions to support progress toward grade specific goals through our MTSS program. Students work in a variety of groups and are provided with targeted small group instruction to provide intervention or extension customized to the learners' needs.

Pleasant Ridge Elementary school also has dedicated time this year to focus on Tier 1 math instruction across curricular areas. It is the district's hope to build teacher capacity in culturally responsive math instruction to support high academic achievement while building relationships that promote social and emotional wellness.
