- 18 out of 26 also donated to individual campaigns
- These 18 groups contributed a total of \$323,000 of the \$392,750 total donated to Improve MS PAC (82%)
- These 18 groups contributed a total of \$111,500 of the \$919,964 combined total donated to Griffis and Coleman (12%)
- These 18 groups contributed a total of \$434,500 of the \$1,312,714 combined total donated to candidates and Improve MS PAC (33%)
- 13 of these 18 are Political Action Committees that must disclose their contributions and disbursements to the MS Secretary of State

- 1 PAC, the Home Builders Association of MS PAC only reported spending in one period, May 1 through May 31
- Of the 12 PACs that correctly filed with the Secretary of State, only 2 donated to any other PAC besides Improve MS
- Of these 12, 9 of them made their largest political contribution to Improve MS (close second largest for MS Realtors and Truck PAC)
