  - o 3 Bedrooms 2 bath
  - o 20 Year forgivable mortgage
  - 10k grant from Philly first home
  - Average is \$185k
  - o Housing vouchers can be used to buy a home
  - o Real estate taxes fund school districts
  - o Priority given to Philadelphia employees
  - PHDC housing counseling

- Maximum household for 1 is \$85,000
- o \$114,000 for household of 4
- Q: Riverwards and PHDC?
  - Qualified developer
  - Are also across the street
- They are all quality houses
- Average is \$1,400 a month
  - \$1,100 before interest rate spike
- Shelby is the community engagement officer
- City owned land (Landbank)
- O Q: What properties are within our catchment?

  - o 3 cases
  - o 2633 Jasper
    - Group living in a single family. Added a fourth resident
    - 28 in favor and 3 opposed
  - o 1938-40 Hazard Street
    - Oversized lot with a garage
    - 5 unit building proposal
    - Parking demand
    - Developer was willing to negotiate but the community wanted a subdivided home (two single family homes)
    - 5 in favor 25 opposed
  - o 1912 E Cumberland St
    - AirBnB
    - Previously used as AirBnB
    - 18 in favor 5 opposed
    - 4th AirBnB to be legalized (Many likely illicit)
    - It lasts into perpetuity for the lot
  - Q: What we provide
    - Vote if no real opposition or conversation
    - Mandatory is date, vote, location
    - We usually editorialize the vote a bit
  - Q: Is council taking on the issue of AirBnB?
    - A: No council person seems to be taking it on
    - 30ish houses
  - o It's a lot of work, need help!
  - Zoning... And planning!!!
- Arts Committee (Paul)
  - Trying to work out nuts and bolts of how the committee will work
  - Will put up a form online for proposals
    - Facilitate other peoples ideas
  - Ambient Lab event
  - Film festival talks
