To Be Enacted in the Atlantic Commonwealth Assembly

Whereas, the Atlantic Commonwealth flag is very outdated

Whereas, the Atlantic Commonwealth flag has no symbolic connection to the Atlantic Commonwealth

Whereas, changing our flag could help more people show our state pride

Whereas, if we change the flag, a changing of the symbols of the Departments of State will need to change.

THE PEOPLE OF THE ATLANTIC COMMONWEALTH, REPRESENTED IN ASSEMBLY,
DO ENACT AS FOLLOWS:

Section I: Short Title, Extent, and Severability

- a) This piece of legislation shall be referred to as the State Flag and Department Logos Act
- b) This act comes into force on the next January 1st after the passage of the Act
- c) The provisions of this act are severable. If one part of this is to be found unconstitutional, then that part will be struck.

Section II: Definitions:

- a) “Flag” shall be defined as the Flag of the Atlantic Commonwealth

Section III: Atlantic State Flag

- a) After the passage of this Act, the Atlantic State Flag shall be changed to this

- b) The flag is described as “A green pine tree on a white field next to 8 white stars surrounding one white star on a green field”.

Section IV: Disposal of Old State Flags

- a) After 30 days of the passage of this act, any citizen of the Atlantic Commonwealth who has an old state flag may trade in an old flag for a new flag of the same size
 - i) If they do not want a new flag, they will receive a monetary amount equivalent to the flag
- b) All the state flags will be either used for the creation of new flags or donated to cloth recycling facilities
- c) There will be no consequences for flying the old flag.

- a) The Office of the Governor’s logo will be changed to this
