CONSTITUTION OF KEDMA

Preamble

We, the Orthodox Jews at the University of Maryland, College Park, in order to establish a stronger religious and social community, organize to form Kedma.

Article I: Notes

Name

- 1.1. Kedma is both the name of the Orthodox Jewish community at the University of Maryland, College Park and the organization that oversees its activities.
- 1.2. Kedma will appear in both many informal settings and be used for SGA purposes.
- 1.3. For the purposes of this document, "Kedma" will be used to refer to the organizations while "the Community" will be used to refer to the members of the Kedma Community, unless otherwise noted.

Affiliation

1.1. Kedma is not affiliated with any national organization. It is a student community within Hillel but has no official connection with Maryland Hillel or Hillel International.

Article II: Purpose

- 1. Kedma's purpose is to facilitate Orthodox Jewish life at the University of Maryland, College Park, in particular for the members of the Community.
- 2. This purpose is achieved through the direction and management of the "Three Pillars upon which the World Stands," as stated in *Avot 1:3*:
 - 2.1. Torah
 - 2.1.1. Kedma facilitates the creation of an atmosphere of Torah learning through maintaining the Maryland Hillel Beit Midrash (study hall), coordinating daily shiurim (learning programs), and inviting guest speakers and scholars-in-residence.
 - 2.2. Avodah (Prayer Service)
 - 2.2.1. Kedma facilitates minyanim (prayer services) on weekdays, Shabbatot (Sabbaths), and yamim tovim (holidays).
 - 2.3. Gemilut Chassadim (Acts of Kindness)
 - 2.3.1. Kedma facilitates the building of a strong community, characterized by kindness, warmth, and friendliness—a conviviality that should project outward to the general Jewish population and campus community as a whole.

As a sector of the broader campus community, Kedma and the Community are bound by all University of Maryland Policies when applicable and will abide by them.

Kedma understands and is committed to fulfilling its responsibilities of abiding by University of Maryland, College Park policies.

Article III: Membership

- 1. Membership in Kedma is defined as being an undergraduate student who has signed up for the Kedma listserv and is enrolled at the University of Maryland, College Park or one of its closely related programs.
 - 1.1. The listserv mailing address is kedma@listserv.umd.edu.
 - 1.2. The Executive Board, as defined below, has access to the listserv and will subscribe or unsubscribe members to and from it upon member request.
- 2. The Executive Board reserves the right to revoke one's membership if said person has committed a severe action in gross violation of Kedma's purpose.
- 3. Kedma has no barriers for membership. Any university student who wishes to can become a member of Kedma. Kedma does not restrict membership or discriminate on the basis of race, color, creed, sex, sexual orientation, gender identity, gender expression, marital status, personal appearance, age, national origin, political affiliation, physical or mental disability, or on the basis of rights secured by the First Amendment of the United States Constitution. (For definitions of "personal appearance" and "sexual orientation," see the University's Code of Human Relations.)
- 4. Kedma events, programs, and activities are open to any member of the University, regardless of membership status.

Article IV: Officers

- 1. Kedma has three types of Officers, each described in the succeeding Articles:
 - 1.1. The President, Vice President, and Treasurer, who comprise the Executive Board;
 - 1.2. The General Gabbai Rishon, General Gabbai Sheni, and Gabbait, who comprise the General Gabbinate;
 - 1.3. Assorted Programming Coordinators; and
 - 1.4. The Committee Chairs

Article V: The Executive Board

- 1. Three elected Officers—the President, Vice President, and Treasurer—combine to form the Executive Board. These three officers must be members of Kedma and undergraduate students currently enrolled in good standing at the University of Maryland, College Park.
- 2. Collective Rights and Responsibilities The Executive Board shall:
 - 2.1. Set and modify Community and Committee standards, as defined in the Kedma ByLaws (henceforth the ByLaws)
 - 2.2. Oversee and facilitate Committee operations, as defined in the ByLaws
 - 2.3. Obtain procedural knowledge, including Executive Board, Committee, and Gabbai procedures (as defined in this document and the ByLaws) and all SGA and Office of Campus Programming procedures, as defined elsewhere.

- 2.4. Facilitate Community feedback
- 2.5. Oversee fundraising initiatives
- 2.6. Have Access to STARS, Orgsync, the listserv, and bank account information
- 2.7. Attend Mandatory SGA Meetings
- 2.8. Develop an annual budget
- 2.9. Maintain constant contact with the other three Officers, as defined in the byLaws
- 2.10. Oversee the conduct of the other Officers and Programming Coordinators, as defined in the ByLaws
- 3. The members of the Executive Board shall not exert their status in making final programmatic decisions for the Programming Coordinators. The members of the Executive Board shall have no role in final programmatic decisions for the Programming Coordinators, except when solicited by a Programming Coordinator.

4. President

- 4.1. The President is in charge of the affairs, business, and property of Kedma and is the face of the Community.
- 4.2. The President maintains veto power in all Executive Board decisions, as defined in the ByLaws.
- 4.3. The President claims the duties of the Vice President, should the Vice President become unavailable.
- 4.4. In addition to the Collective Rights and Responsibilities laid out in §V.2 and above, the President's rights and responsibilities are defined in the ByLaws.

5. Vice President

- 5.1. The Vice President claims the aforementioned duties of the President, should the President become unavailable.
- 5.2. In addition to the Collective Rights and Responsibilities laid out in §V.2 and above, the Vice President's rights and responsibilities are defined in the ByLaws.

6. Treasurer

- 6.1. The Treasurer is responsible for Kedma's financial affairs.
- 6.2. In addition to the Collective Rights and Responsibilities laid out in §V.2 and above, the Treasurer's rights and responsibilities are defined in the ByLaws.

7. Board Terms

- 7.1. The President and Vice President each serve for one semester.
- 7.2. Thereafter, the Vice President becomes the new President and a new Vice President is elected.
- 7.3. The Treasurer serves for one full year, two full semesters.

Article VI: The Gabbaiim (Synagogue Officers)

- 1. Each Kedma minyan (prayer service) is overseen specifically by a pair of Gabbaiim— a Gabbai Rishon (Primary Synagogue Officer) and Gabbai Sheni (Secondary Synagogue Officer)—and more generally by the General Gabbinate.
- 2. General Gabbai Rights, Responsibilities, and Qualifications
 - 2.1. All Gabbaiim are responsible for the daytoday management and decisionmaking of the minyanim they oversee, as defined in the ByLaws.
 - 2.2. All Gabbaiim must be members of Kedma and undergraduate students currently enrolled in good standing at the University of Maryland, College Park.

3. General Gabbinate

- 3.1. The General Gabbinate is responsible for overseeing the overall state of minyanim at the University of Maryland, College Park and for the ultimate cooperation of all of its member minyanim, resolving logistic and communal conflicts as they arise.
- 3.2. General Gabbinate plays no role in the religious or structural bases of its member minyanim, excepting the case where solicited by a member minyan.
- 3.3. The General Gabbinate is itself overseen by the General Gabbai Rishon, the General Gabbai Sheni, and the General Gabbait, whose individual rights and responsibilities are detailed in the ByLaws and are in addition to their other Gabbai responsibilities for the particular minyanim they run.
- 3.4. The General Gabbai Sheni advances into the role of General Gabbai Rishon after one year in office.
- 3.5. The General Gabbinate runs parallel to the Executive Board, in a relationship defined in the ByLaws.

Article VII: The Programming Coordinators

- 1. General Purpose
 - 1.1. The Programming Coordinators each take responsibility for a specific area of programming and coordinating its realization in the community.
- 2. Programming Coordinators rights and responsibilities.
 - 2.1. The mission of a Programming Coordinator is to attend to a need of Kedma and/or the Community.
 - 2.2. It is the responsibility of the Programming Coordinator to build efficiently and effectively towards the achievement of that mission.
 - 2.3. This may be accomplished through events, programs, initiatives, and/or projects.
 - 2.4. Programming Coordinators have the responsibility of understanding and anticipating the larger, resounding impact their actions make in the Community at large, while still providing their target recipients with something of value.
 - 2.5. Programming Coordinators have the responsibility to be open to accepting ideas and help from Community members at large.

- 2.6. Programming Coordinators have the responsibility of carrying out the entire programming process flow of Inception, Detail Determination, Logistics (excluding Finances), Marketing, and Final Execution, as detailed and defined in the ByLaws.
- 2.7. Programming Coordinators have the right to Kedma funds and inclusion in general advertising, as determined by the Executive Board.
- 2.8. Programming Coordinators have the right to guidance from the Executive Board and other Officers.
- 2.9. Terms
 - 2.9.1. A Programming Coordinator's term is one cycle, as defined in the ByLaws.

Article VIII: The Committees

- 1. General Purpose
 - 1.1. The Committees, as a group, form a useful tool for the Community.
 - 1.2. Individual Committee conception, growth, maturity, decline, and death; interCommittee mergers and splits; and the internal systems that govern those Committees are intended to be organic and match the needs of Kedma and the Community.

2. Committees Classes

- 2.1. There are three classes of Committees
 - 2.1.1. Standing Committees serve functions throughout the year.
 - 2.1.2. Annual Committees serve functions annually but for only a specific amount of time.
 - 2.1.3. Ad Hoc Committees serve functions that arise to provide for specific needs and typically disband once the issue is resolved.
- 2.2. These class specifications provide various differentiations, as detailed and defined in the ByLaws.
- 3. Committee Rights and Responsibilities
 - 3.1. The mission of a Committee is to attend to a need of Kedma and/or the Community.
 - 3.2. It is the responsibility of the Committee to build efficiently and effectively towards the achievement of that mission.
 - 3.3. This may be accomplished through events, programs, initiatives, and/or projects.
 - 3.4. Committees have the responsibility of understanding and anticipating the larger, resounding impact their actions make in the Community at large, while still providing their target recipients with something of value.
 - 3.5. Committees have the responsibility to be open to accepting ideas and help from Community members at large.
 - 3.6. Committees have the responsibility of carrying out the entire programming process flow of Inception, Detail Determination, Logistics (excluding Finances), Marketing, and Final Execution, as detailed and defined in the ByLaws.

- 3.7. Committees have the right to Kedma funds and inclusion in general advertising, as determined by the Executive Board.
- 3.8. Committees have the right to guidance from the Executive Board and other Officers.

4. Committee Charters

4.1. Each committee operates both internally and with the rest of the system as laid out in its Committee Charter, as defined in the ByLaws.

5. Committee Chairs

- 5.1. Committee Chairs run one or more committees with the same larger purpose or general theme.
- 5.2. All Committee Chairs must be members of Kedma and undergraduate students currently enrolled in good standing at the University of Maryland, College Park.
- 5.3. Committee Chair Rights and Responsibilities
 - 5.3.1. Serving as the senior member of their respective Committee(s)
 - 5.3.2. Overseeing the direct operations and decisionmaking of their respective Committee(s)
 - 5.3.3. Communicating the standards laid out by the Executive Board to the members of their Committee(s)
 - 5.3.4. Keeping regular contact with the Executive Board, as defined in the ByLaws
 - 5.3.5. Ensuring the upholding of the Charter(s) of his/her Committee(s)

5.4. Terms

5.4.1. A Committees Chair's term is one cycle, as defined in the ByLaws.

6. Committee Formation

- 6.1.1. New Committees can be formed in one of three ways:
- 6.1.2. Splitting is the process of breaking one current Committee into multiple Committees, whether under the same Committee Chair or not
- 6.1.3. Joining is the process of consolidating two or more overlapping Committees into a single new Committee
- 6.1.4. Creating is the process of devising an entirely new Committee
- 6.1.5. The three methods are detailed and defined in the ByLaws.

Article IX: Jewish Learning Initiative on Campus

- 1. Hillel and the Orthodox Union provide Kedma with an Orthodox rabbinic couple (henceforth the Educators) through the Jewish Learning Initiative on Campus.
- 2. The Educators work with Kedma and the Community to provide Torah learning initiatives and address communal issues.
- 3. Matters of halacha (Jewish law) and minhag (Jewish custom) should be brought to the attention of the Educators.

- 4. Kedma and the Educators should be in constant contact to produce a vibrant, diverse, and inviting religious atmosphere—a relationship that is defined, in part, in the ByLaws.
- 5. Kedma and the Community should guide Hillel and JLIC in the process of selecting new Educators.

Article X: Elections and Resignations

- 1. Executive Board Elections
 - 1.1. Eligibility
 - 1.1.1. Eligibility for candidacy for an Executive Board position is detailed in the ByLaws.
 - 1.2. Process
 - 1.2.1. The election process is to take place at the end of the semester before a new Executive Board member's term is to begin, as is detailed in the ByLaws.
 - 1.3. Unfilled Positions
 - 1.3.1. Any unfilled position on the Executive Board at the end of an election session must be filled using the process detailed below under Resignation.
 - 1.4. Resignation
 - 1.4.1. If an Executive Board member resigns or for whatever reason leaves his/her position, the remaining Executive Board members (or General Gabbinate if there are no other Executive Board members) nominate another member of Kedma to fill the position, who must then be confirmed by a majority of the current Officers.
- 2. Selection of the General Gabbinate
 - 2.1. Eligibility
 - 2.1.1. Criteria for eligibility for General Gabbai are detailed in the ByLaws.
 - 2.2. Process
 - 2.2.1. The current General Gabbinate selects new General Gabbaiim with direction from the Executive Board, as defined in the ByLaws.
 - 2.3. Resignation
 - 2.3.1. If a General Gabbai resigns or for whatever reason leaves his/her position, the remaining General Gabbai (or Executive Board if there are no other General Gabbaiim) nominate another member of Kedma to fill the position, who must then be must be confirmed by a majority of the current Officers.
- 3. Programing Coordinator Selection
 - 3.1. Programming Coordinators are selected according to their Committee Charters, as laid out in the ByLaws.
- 4. Committee Chair Selection
 - 4.1. Committee Chairs are selected according to their Committee Charters, as laid out in the ByLaws.

5. Restrictions

5.1. No one may occupy more than one Kedma Officer position at any one time. 6. General Resignation 6.1. Any Executive Board member or member of the General Gabbinate that chooses to resign for whatever reason may never again run or be in the consideration for any Officer position.

Article XI: Operations

- 1. Registration Renewal
 - 1.1. Kedma will apply to OrgSnc for registration on an annual basis no later than the date listed in the ByLaws.
- 2. Meetings and Voting
 - 2.1. Types, regularity, and procedure of meetings are defined in the ByLaws.
- 3. Finances
 - 3.1. Kedma receives funding from the SGA through the student group budget process.
 - 3.2. Kedma receives other funds through assorted fundraisers. These funds are typically allocated to items that Kedma is unable to buy with SGA funds.
 - 3.3. Only the Executive board has the authority to control Kedma finances and only the members thereof may delegate that authority.
 - 3.4. Kedma is not responsible for purchases or financial commitments made without clearance from the Executive Board.

4. Conduct

- 4.1. Kedma Officers must conduct themselves in accordance with the generally accepted standards and values of Orthodox Judaism and must consider themselves Orthodox Judaism's representatives to the campus as a whole.
- 4.2. An overview of the generally accepted standards and values of Orthodox Judaism are defined in the ByLaws.

5. Impeachment

- 5.1. An Officer that does not fulfill his/her obligations as enumerated above or in any official Kedma document is liable for impeachment.
- 5.2. Five Officers or thirty (30) Community members can submit an official request to the Executive Board for an impeachment hearing.
- 5.3. This is followed by an impeachment procedure as defined in the ByLaws.

Article XII: Amendments

- 1. Amendments to this Constitution
 - 1.1. Must be presented in an open forum and
 - 1.2. Must be ratified by two-thirds vote by a quorum of Community members in attendance of the open forum.

2. Earlier versions

2.1. The original Kedma Constitution was ratified by the Kedma Board during the Spring semester of 2003 and went into effect in the Fall of 2003. The Kedma board updated said constitution in the Fall of 2006, the Fall of 2008, the Spring of 2009, the Fall of 2010, and the Spring of 2017. Beginning Spring 2012, and with this version of the Constitution, all legal documents shall be posted on the Kedma Website, open to any who wish to view them.

3. Current Version

3.1. The current version was drafted and ratified by the Kedma Board and Gabbaiim in the Spring of 2017 and went into effect immediately upon SGA approval.
