

-[Method]-

- 1: I brief my CDs.
- 2: I assign the CDs nicknames (CD-1 and CD-2)
- 3: I explained to CD-1 that he needs to look at O96 first before stabbing CD-2 with SCP-O34.
- 4: I explain that upon using O34 you are to not look at SCP-O96's face and remain facing the wall during and after the usage of SCP-O34.
- 5: I explained to CD-2 that for the duration of this test, he is to always be staring at the wall he is facing and to never look at SCP-096.

- 6: I ask if either of my CDs have any questions or are confused about what to do.
- 7: CD-1 tells me that he is ready.
- 8: CD-2 tells me that he is also ready.
- 9: I inform my escort that the CDs are briefed.
- 10: The test was ready to proceed.
- 11: I, along with my spectators, enter the observation room.
- 12: My C-9 escort takes the CDs to the entry gate.
- 13: My C-9 allows the CDs to enter.
- 14: The CDs enter facing away from SCP-096's crate.
- 15: The CDs are taken near SCP-096's crate without SCP-096's crate being opened to ensure success for the duration of the test.
- 16: The CDs are placed within their designated area around SCP-096's crate.
- 17: Before the crate is opened CD-1 walks up to SCP-034's crate.
- 18: CD-1 opens SCP-034's crate.
- 19: CD-1 grabs SCP-034 as instructed.
- 20: SCP-096's crate is opened revealing SCP-096.
- 21: CD-1 with SCP-034 in hand looks at SCP-096's face as instructed.
- 22: CD-1 looks at SCP-096's face and triggers SCP-096.
- 23: Upon triggering SCP-096 CD-1 walks up to CD-2 who is facing a wall and uses SCP-034 on CD-2.
- 24: CD-1 copies CD-2's appearance.
- 25: CD-1 with CD-2's appearance faces away from SCP-096.
- 26: SCP-096 is still in his enraged state.
- 27: CD-1 continues to face a wall with CD-2's appearance.
- 28: SCP-096 becomes more enraged and chases down CD-1.
- 29: Even with CD-2's appearance SCP-096 continues to chase CD-1.
- 30: SCP-096 catches CD-1 and kills CD-1.

- 31: I document the results of SCP-096's actions and what happened during the test.
- 32: I inform all who are participating in the test that the test is concluded.
- 33: I thank all participants, escorts included, for helping with the test today.
- 34: I conclude my test and leave Epsilon.
- 35: Test Concluded.

-[Results 1-

Upon copying CD-2's appearance SCP-096 appeared to still be enraged due to CD-1 initially looking at SCP-096's face meaning even after copying someone else's appearance, SCP-096 was still enraged by CD-1 even with CD-2's appearance. Meaning to answer the question, If someone were to trigger SCP-096 and then stab someone with SCP-034 would SCP-096 still go after the person that triggered it or, due to the person looking different in every way, would SCP-096 become docile again? SCP-096 remains enraged at the original person who looked at SCP-096's face. A theory I have is due to the results of this test, does this mean SCP-096 has the intelligence necessary to decipher between a 034 and the original person? I believe SCP-096 would be able to tell between a 034 and an original person due to SCP-096 still being enraged at the original person even after using SCP-034 to change his appearance. A test question I have is, if SCP-096 were to be triggered by someone who is golden by being under the effects of SCP-914 would SCP-096 be capable of taking down the golden person? If so, how many attempts would it take 096 before successfully killing the person? If this test were to be proven correct, would this mean that someone with enough durability modification, be able to withstand SCP-096? Would SCP-096 give up on his pursuit and become docile? Or, would SCP-096 continue to pursue the person indefinitely? If the previous tests are proven successful and true if SCP-096 can tell between a 034 and the original person can SCP-096 be capable of seeing a person under the effects of SCP-1200-58? Would SCP-096's trigger identify that person as alive? Can that person successfully look at SCP-096's face without enraging SCP-096?
