We are unable to provide refunds or credits for any classes, lessons, workshops, or performances that are canceled or are unable to proceed as the result of governmental orders, natural disasters, or pandemic.

I/We acknowledge that my child may be videotaped or photographed for education, performance and advertising purposes.

In consideration of being allowed to participate in the classes, competition, and services offered by To The Pointe! Dance Academy LLC (the "Classes"), I, for myself and my child under the age of eighteen (18), agree as follows:

In the event that any term of this Agreement is held to be invalid, illegal, or unenforceable in any respect, that holding shall not affect the validity, legality, and enforceability of any other term. Competition Fees: Competition fees, as applicable, are split into three monthly payments (additional due if national competition attendance awarded). Competition fees are due by January 1, February 1 and March 1 of 2026. Competition fees for the upcoming 2025-2026 season will be shared in Summer, 2025. Competition fees are non-refundable.

Financial Due Dates and Service Charges: Tuition is due on the 1st of each month. A \$30 service charge is applied to accounts not paid by the 10th of each month. Students will not be allowed to participate in dance class or dance-related activities if accounts carry a balance of greater than 30-days.

Automatic Enrollment: Students are automatically enrolled through May 31, 2026 (or December, 2025 if enrolled in the Fall 2025 12-week Session). Notice of a drop must be in writing 30-days prior to the first of the month in which the drop occurs.

Exclusions: The following items are excluded from tuition: dance attire, dance shoes, dance pictures, Christmas and Spring recital tickets (approximately \$17-\$19 per ticket) and other miscellaneous items are excluded from tuition payments.

Shoe requirements:

• Dance shoe requirements are set forth by class and determined the summer before the start of each season. Requirements will be published on our website and communicated in a timely fashion. It is important to wear the appropriate shoes for a uniform look in studio and on stage.

Apparel requirements:

Fitted dance attire in the colors of ballet pink or black. Dance tights, ballet skirts and leotards in the colors of pink or black are required for all ballet classes.

Fall 2025 12-Week Classes:

• I understand the Fall 2025 classes will have one recital performance at the Christmas Show (date TBD) and one costume/costume fee requirement. We will do our best to utilize the same costume for both fall and spring 12-week sessions but this is solely based on availability.

Spring 2026 12-Week Classes:

• I understand the Spring 2026 classes will have 1-2 recital performances at the Spring Show (date TBD) and one costume/costume fee requirement. We will do our best to utilize the same costume for both fall and spring 12-week sessions but this is solely based on availability.

9-Month Classes (September 2025-May 2026):

• I understand 9-month classes will have 1 recital performance at the Christmas Show as well as performances in the Spring Show (dates TBD).

Costume/costume fee requirements:

- Pre-K 1 costume/fee (the same costume will be worn at both the Christmas and Spring recitals)
- K/1 1 costume/fee (the same costume will be worn at both the Christmas and Spring recitals)
- Grade 2/3 & Grade 4/5 2 costumes/2 costume fees (the same costume will be worn at both the Christmas and Spring recitals)
- Middle & High School Lyrical/Jazz 2 costumes/2 costume fees (the same costume will be worn at both the Christmas and Spring recitals)
- Middle & High School Tap Only 1 costume/fee (the same costume will be worn at both the Christmas and Spring recitals)
- Hip Hop 1 costume/fee (the same costume will be worn at both the Christmas and Spring recitals)
- Beginner Ballet 1 costume/fee (the same costume will be worn at both the Christmas and Spring recitals)
- Pointe 1 costume/fee (the same costume will be worn at both the Christmas and Spring recitals)
