JSgt. Nikolai 'Polak' Borodichi says "Ah, Sergeant Major. You know of the issue that Marco reported, right?"

JSgt. Nikolai 'Polak' Borodichi says "With a POW being shot after surrendering?"

SgtMaj. Lukas Schussler says "No, not really."

SgtMaj. Lukas Schussler says "Oh, that one."

JSgt. Nikolai 'Polak' Borodichi says "Yes."

SgtMaj. Lukas Schussler says "Yeah, what of it?"

JSgt. Nikolai 'Polak' Borodichi says "I'm trying to find out who SHOT the POW."

SgtMaj. Lukas Schussler says "It doesn't matter, there was no order to take POWs."

SgtMaj. Lukas Schussler says "Well, he's lying."

SgtMaj. Lukas Schussler says "I'm saying it doesn't matter."

JSgt. Nikolai 'Polak' Borodichi says "And the Captain says otherwise, sir."

JSgt. Nikolai 'Polak' Borodichi says "I'm just trying to get all the facts straight."

SgtMaj. Lukas Schussler says "And I don't give a fuck what he says, he wasn't there."

**(MARCO ENTERS)**

**SSdr. Marco Krakov says "Hey ."**

**JSgt. Nikolai 'Polak' Borodichi says "Oh, hello Marco!"**

**SSdr. Marco Krakov says "I Got some information on the Thing ."**

SSdr. Marco Krakov says "The shot that killed him was a Dragov."

(NOTE: Statements contradict, Sergeant Major Schussler says nobody said to take POWs, then claims that the CO only said that for his patrol, admitting it was ordered)

**SSdr. Marco Krakov says "You where their was the same speech I was?"**

**JSgt. Nikolai 'Polak' Borodichi says "I already have Taken it up with Captain Ritter. And I was given full permission to act on this investigation and I would like you to handle this like a mature person and Wait. Your. Turn."**

## Post investigation notes

Investigation of Warrant Officer Emilie Schultz for execution of  
surrendering P.O.W

Interview of Senior Soldier Marco Krakov and Team Leader of  
Spetsnaz Fireteam Sergeant Major Lukas Schussler.

When the interview began, the Sergeant Major (shorted to S.M.L) was aggressive at the beginning, claiming Senior Soldier Marco Krakov (Shortened to SSdrM) was lying about the POW being shot. S.M.L then became more and more defensive and rude as the interview went on, swearing, claiming I and SSdrM were liars, and that I am a "Fucking Base Operative" throughout the interview he said his word was all that mattered, and continued to interrupt SSdrM and threaten me.

I assume he is only trying to protect Emilie, and should be charged as an accomplice for trying to cover up Emilies warcrimes. Under

military law Emilie Schultz performed a Summary Execution of a Prisoner of war after he surrendered in the field.
