Talk to friends- You may have several friends who may be familiar with some or the other personal injury attorneys. A good attorney may not even take the case to the court or negotiate for settlement. He may just write a letter or conduct a meeting with your insurance company or with the defendant to receive the settlement payment.

Hire somebody who is familiar with the area and is local to the area. An outsider may not be familiar with the courts in that area.

Initial consultation- Try to build a good rapport with your attorney. You need to build trust and have confidence in his approach to the case. Try to have an initial consultation to get to know the attorney better.
