Mandy: "For Quincia, do we all have accounts"

Legislation SR #2-242: 1st Reading — Open Dissertations
 Introduced by Rachel.

QnA

Austin: "On the point of inviting people, when you invite them: is it virtual or in-person" It will be a Zoom link. It will be an unobtrusive and convenient way of having community members present and then have a private, closed questioning with the dissertation committee member.

Austin: "I make a recommendation to specify "Zoom" meeting in the resolution" Meghana; "DO other schools offer zoom or also offer in-person"



It depends. Some mandate an open in-person dissertation, whereas others offer only zoom.

Jude: "I would vouch for and recommend an option or possibility of in-person"

Emma: "What is the reasoning for the no in-person option".

There is no reasoning from the Office of Dissertation Department. But perhaps because it is an extension of GSAS policy, maybe it was just absorbed without reasoning. It just is what it is.

Emma: "Is there a reason why the legislation is only sticking to Zoom?"

The only reason to stick to Zoom was to at least get the ball rolling on having open dissertation and make it feasible to entertain the possibility of some kind of open dissertation. And hope for more options in the future.

Neha: "Is there a reason for specifying the open dissertation for 15 minutes?"

It is because the Office Of Doctoral Dissertation recommends 15 minutes for the presentation.

And We want the legislation to be as feasibly accepted as possible so recommending too many changes may hinder the resolution from being implemented.

Also closed questioning will always be confidential to protect students and committee members and promote an open discussion, without pressure from other people present.

Emma: "Capitalize "student senate" on 3c. Also are statistics from the survey shared with the student senate?"

Yes, because advising data is never shared with anyone. So the student senate having this survey results can inform us of the advising situation better and recommend more resolutions.

Joshua:" I want more context around the "degree audit tool" for doctoral students (3b). "A lot of new students do not know what the degree audit is. It is a tool that outlines what classes you need to graduate, so many students who do not know of it may only depend on word of mouth. So officiating students knowing it could be beneficial.

Li (and Jebraune in the chat):" Perhaps this is another issue but the degree audit is non-function."

POI from Denise: a new software for degree audit will be introduced soon! "Degree Works"

Also, that is why the resolution says "degree audit tool" because there may be multiple iterations for it.

Emma: "I do not know if 3c is fully representative of the current situation. There are ways for the Senate to access data on advising. Forcing the institution to share data with the Student Senate could cause wariness. SO maybe reword it?"

Yes, this is forceful but it speaks to a frustration of how difficult and laborious actually accessing the data is.

Neha: "I think it (3c) is a good point to make and I would recommend putting it earlier in the resolution. But one reason why data is hard to access and vague is for protecting student confidentiality and coordinating information for a student body as large as this. Maybe making it as a reference rather than a requirement could be more beneficial".
