Background:

The clean energy transition is expected to drive a rapid increase in minerals and metals consumption, the vast majority of which will be from primary sources. The communities that are hardest-hit by the increase in primary resource demand are often traditionally marginalised communities - women, children, and indigenous groups.

This session considers this increase in resource requirements from an intergenerational perspective, and dives into two key topics: **1. Efficient Resource Use** and **2. Sustainable Resource Extraction.**

Efficient resource use discusses the design and creation of products, processes, and systems that are intended to be reused, repaired, remanufactured, or recycled, thus minimizing waste. In particular, it will examine the role of young people in shaping individual and collective consumer behaviour.

Sustainable resource extraction discusses the impacts of the minerals and metals industry, and strategies to ensure that present-day economic activity does not result in environmental destruction to be cleaned up by future generations.
