Call to Order by Superintendent Mark Tucker

**Reorganization of the board**

2 CCSU Board Reps – Jason Monaco nominates Ellen Cairns and Chris Tormey to remain as the 2 reps and seconded by Erica Fucello. Nomination passed.

Ellen Cairns nominates Erica Fucello to continue to serve as the alternate and seconded by Jason Monaco. Nomination passed.

Negotiations Council – Jason Monaco nominates Chris Tormey and seconded by Ellen Cairns. Nomination passed.

CVCC Rep – Ellen Cairns nominates Jason Monaco and seconded by Chris Tormey. Nomination passed.

Superintendent Evaluation Committee – Jason Monaco nominates Ellen Cairns and seconded by Erica Fucello. Nomination passed.

Set Regular Board Meeting Schedule – 4<sup>th</sup> Monday of every month but will look at a different time when the new Superintendent is in place.

**Public Comment -**

Frank Kampf (Cabot) – a domain has expired. Mark will check into it.

Daniel Dunham (Cabot) - Believes some of the issues for Cabot is leadership. Would like to see new leadership that communicates with all families. What is the process for changing leadership? Division seems to be coming from the leadership. Mark Tucker noted that the principal is on a contract for another year. Ellen wanted to go on record that she has a lot of respect for the Cabot principal. What are the next steps? Chris noted in the past concerns were brought to the Superintendent and a plan is made with the principal to see if they can improve their performance. At one point a town wide survey was done with a past principal and then the Superintendent opted not to renew the principal's contract. Mark Tucker noted that concerns need to be put in writing to him. From there he will take appropriate action.

Morgan Churchill (Cabot) – likes the idea of a survey going out. What happened to the school to work program? His son currently participates in one, but it was a hard sell to the school, and they had to register as a hybrid home school. Ski program – has it changed that home school students can no longer participate in winter wellness? Would like to see the actual policy.

Danielle Warner – last year there was a survey buried in an email. Results came back but seem dismissed.
