[1] - initial investigation

The initial investigation revealed that

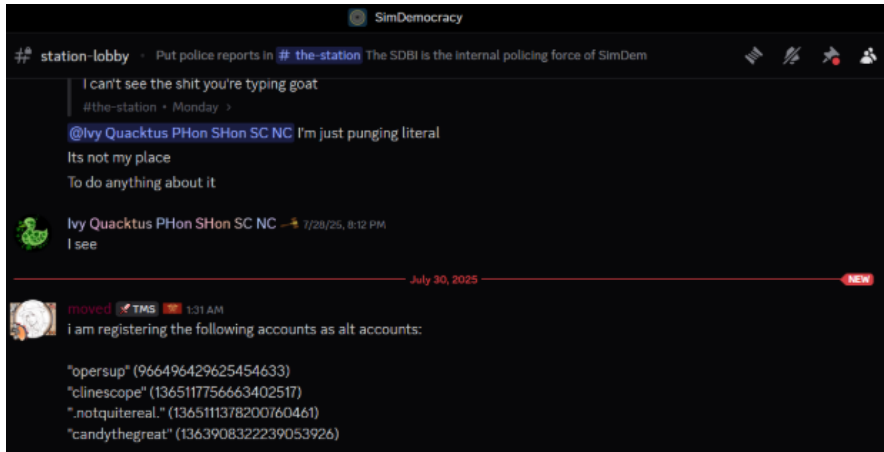
- Moved had 5 accounts on simdem at a point.
- currently only one of these 5 accounts is on simdem (Movedhide)
- these are all of moved's alts

[2] - overall findings

- moved registered her alts in #the-station on 30th July 2025



- this was months after the accounts joined the simdem server
- on enquiring with the DoVR, I found out that 4 out of these 5 accounts had a valid SUIT
