4. Warranty Policy

Warranty covers manufacturing defects or structural issues not disclosed at purchase.

The warranty does not cover:

- Road hazards
- Improper installation or maintenance
- Misuse or off-road use

b. New Tires

- All new tires come with a 3-month limited warranty from the date of purchase or installation
- Includes manufacturer warranty if applicable
- Customers must retain their proof of purchase and installation

c. Warranty Claims

- Photos, proof of purchase, and a brief explanation are required
- Warranty replacements or refunds are at the discretion of Tire Spot Solutions LLC
