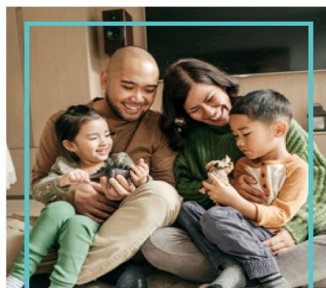

Get monthly checks for raising kids with the Child Tax Credit

You could get up to \$3,600 per child under 6 years old and up to \$3,000 per child between 6 and 17 years old from the government.

The Child Tax Credit is not a loan.

Who qualifies?

Almost all families qualify for the Child Tax Credit. Even families that haven't filed a tax return or don't have recent income.

Anyone with a child who has a Social Security number can get the Child Tax Credit, even if they don't have a Social Security number themselves. Receiving this tax credit won't change any public benefits you receive.

When will I get the money?

Half of the credit will be issued in monthly payments in 2021. You must file a tax return in 2022 to get the other half.

How do I get the credit?

If you haven't gotten your credit yet, you will need to send your info to the IRS.

Beware of scams. The IRS will NOT contact you by phone, email, text, or social media.

Reciba cheques mensuales del Crédito Tributario por Hijos por la mantención de los hijos

Podría recibir del gobierno hasta \$3,600 por cada niño menor de 6 años y hasta \$3,000 por niños de entre 6 y 17 años.

El Crédito Tributario por Hijos no es un préstamo.

¿Quién califica?

Casi todas las familias califican para el Crédito Tributario por Hijos. Incluso familias que no han presentado la declaración de impuestos o que no tienen ingresos recientes.

Cualquier persona que tenga un hijo con un número de Seguro Social puede recibir el Crédito Tributario por Hijos, aunque ellos mismos no tengan un número de Seguro Social. Recibir este crédito fiscal no cambiará ningún beneficio público que esté recibiendo.

¿Cuándo recibir el dinero?

La mitad del crédito se emitirá en pagos mensuales en 2021. Deberá presentar la declaración de impuestos en el 2022 para obtener la otra mitad.

¿Cómo puedo recibir el crédito?

Si aún no ha recibido su crédito, deberá enviar su información al IRS. Tenga cuidado con las estafas. El IRS NO se comunicará con usted por teléfono, correo electrónico, mensaje de texto o las redes sociales.

Keeping Riverside County Families and Residents Housed

United Lift is a rental assistance program coordinated between Riverside County, Inland SoCal United Way, and Lift To Rise with the goal of **keeping local families and residents housed.**

United Lift has now dispersed all of the rental funding available through the CARES Act.

Rental assistance funds from other sources are still available but include expanded eligibility requirements. To be income eligible, a household's income can not exceed 80% of the Area Median Income in Riverside County. All members of the household will be asked to provide proof of income for all income sources.

Together, we are currently reviewing more than 2,500 applications under those new requirements, which is adding time to the application process. If you have already applied, you will be notified once your application has been reviewed.

The rental assistance application remains open, but new applications will be placed on a waiting list with applications reviewed on a rolling basis.

Thank you for your patience as we work quickly and ensure that Riverside County residents are getting the support they deserve.

Funeral Cost Assistance for COVID-19 Related Deaths

FEMA Advisory

FEMA to Help Pay Funeral Costs for COVID-19-related Deaths

In early April, FEMA will begin providing financial assistance for funeral expenses incurred after Jan. 20, 2020 for deaths related to coronavirus (COVID-19) to help ease some of the financial stress and burden caused by the pandemic. The policy was finalized today, and FEMA is now moving rapidly to implement this funeral assistance program nationwide.

To be eligible for COVID-19 funeral assistance, [the policy states](#):

- The applicant must be a U.S. citizen, non-citizen national, or qualified alien who incurred funeral expenses after Jan. 20, 2020 for a death attributed to COVID-19.
- If multiple individuals contributed toward funeral expenses, they should apply under a single application as applicant and co-applicant. FEMA will also consider documentation from other individuals not listed as the applicant and co-applicant who may have incurred funeral expenses as part of the registration for the deceased individual.
- An applicant may apply for multiple deceased individuals.
- The COVID-19-related death must have occurred in the United States, including the U.S. territories and the District of Columbia.
- This assistance is limited to a maximum financial amount of \$9,000 per funeral and a maximum of \$35,500 per application.
- Funeral assistance is intended to assist with expenses for funeral services and interment or cremation.

In the coming weeks, a dedicated 800 number will be established to help individuals who apply. In the meantime, potential applicants are encouraged to start gathering the following documentation:

- **An official death certificate** that attributes the death to COVID-19 and shows that the death occurred in the U. S. The death certificate must indicate the death “may have been caused by” or “was likely the result of” COVID-19 or COVID-19 like symptoms. Similar phrases that indicate a high likelihood of COVID-19 are considered sufficient attribution.
- **Funeral expense documents** (receipts, funeral home contract, etc.) that include the applicant’s name, the deceased individual’s name, the amount of funeral expenses, and the dates the funeral expenses were incurred.



FEMA

- **Proof of funds received from other sources** specifically for use toward funeral costs. Funeral assistance may not duplicate benefits received from burial or funeral insurance, financial assistance received from voluntary agencies, federal/state/local/tribal/territorial government programs or agencies, or other sources.

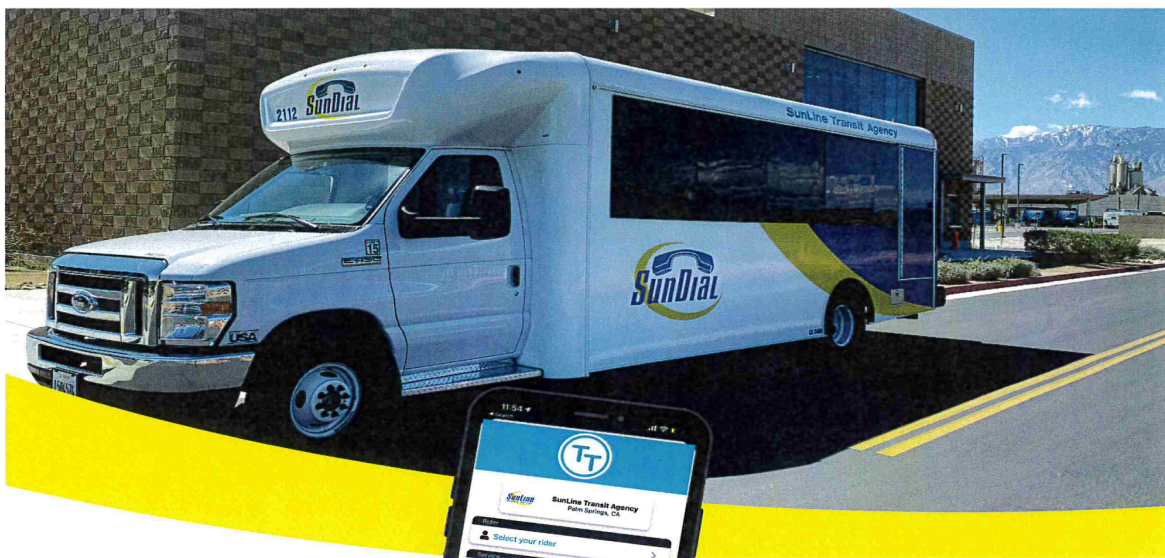

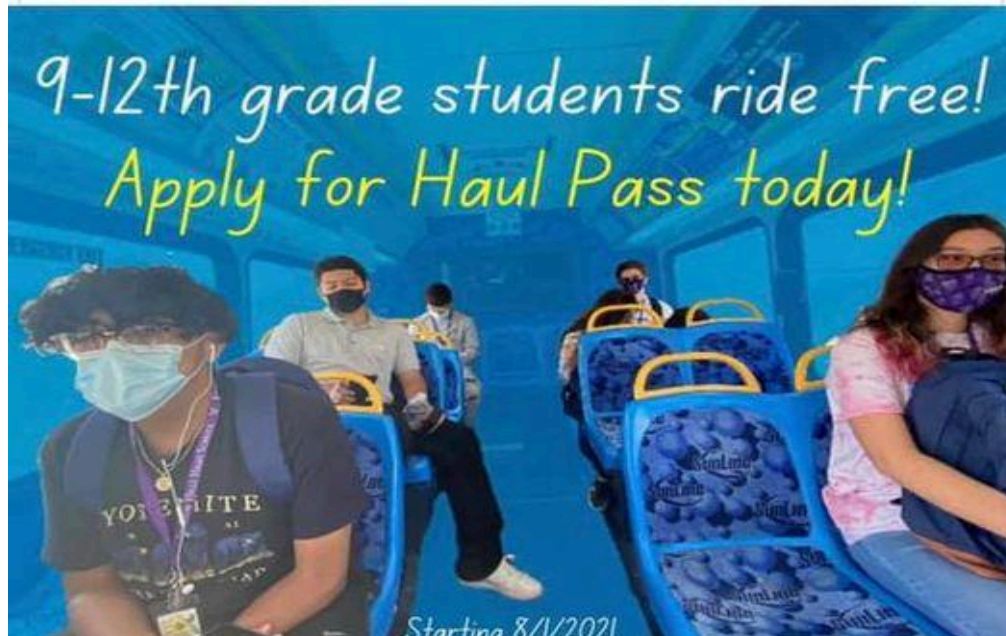

- **One-time Device Discount:** Up to \$100 for a laptop, tablet, or desktop computer (with a co-payment of more than \$10 but less than \$50) where available

Only one monthly service discount and one device discount is allowed per household. The program rules recognize there may be more than one eligible household at the same address.

P-EBT 2.0

As of May 1, 2021, California has not been approved to issue P-EBT 2.0 benefits. To provide P-EBT benefits for the 2020-21 school year, states must develop and submit a P-EBT plan for federal approval. The CDSS and CDE are currently working in partnership to collect the information necessary to submit an approvable plan. Updates regarding P-EBT 2.0, including information about how P-EBT 2.0 will be implemented and when, will be shared here as soon as they are available.

How to Prepare for P-EBT 2.0

To prepare for P-EBT 2.0, eligible families with school aged children should make sure that their school has their most current mailing address on file. There will be no P-EBT 2.0 application. When P-EBT 2.0 begins, cards will be mailed directly to eligible children based on the mailing address on file with their school.

Schools should encourage eligible families to update their mailing address as soon as possible and no later than March 12, 2021

P-EBT 2.0

A partir del 1 de mayo de 2021, California no ha sido aprobada para emitir beneficios P-EBT 2.0. Para prepararse para P-EBT 2.0, las familias elegibles con niños en edad escolar deben asegurarse de que su escuela tenga registrada su dirección postal más actual. No habrá aplicación P-EBT 2.0. Cuando comience P-EBT 2.0, las tarjetas se enviarán por correo directamente a los niños elegibles según la dirección postal registrada en su escuela.

Las escuelas deben alentar a las familias elegibles a actualizar su dirección postal lo antes posible y a más tardar el 12 de marzo de 2021.

Disaster Relief Assistance for Immigrants

Disaster Relief Assistance for Immigrants

The California Department of Social Services (CDSS) is administering the Disaster Relief Assistance for Immigrants Project ("Project"). The project provides one-time disaster relief assistance to undocumented adult immigrants impacted by COVID-19, who are ineligible for most other forms of pandemic assistance, including direct assistance under the CARES Act and unemployment insurance.¹ CDSS-funded nonprofit organizations will distribute \$75 million² in disaster relief assistance to an estimated 150,000 undocumented adult immigrants. Nonprofit organizations will begin providing these disaster assistance services in May.

Direct Assistance: Eligible undocumented adult immigrants may receive one-time COVID-19 disaster relief assistance at a value of \$500. A limit of two undocumented adults per household can receive this assistance (maximum assistance of \$1,000 per household).

Eligibility Criteria: Nonprofit organizations will assess individuals for assistance eligibility based on further guidance from the Department. At a minimum, an eligible individual must provide information that (1) they are an undocumented adult (person over the age of 18); (2) not eligible for federal COVID-19 related assistance, including CARES Act tax stimulus payments or pandemic unemployment benefits; and, (3) has experienced a hardship as a result of COVID-19.

Assistance Delivery: CDSS will select immigrant-serving community-based nonprofit organizations to conduct targeted outreach, application assistance, and delivery of the disaster relief assistance to eligible individuals. The list of the selected nonprofit organizations will be available in May. The identified organizations have existing agreements with CDSS to provide immigration services and have the expertise and experience to assist immigrants with other wrap around supports including direct delivery or referrals to legal, social, health and mental health services.

These nonprofit organizations will prioritize reaching low-income undocumented adults across the numerous ethnic and language immigrant groups in California.

Nonprofit staff will assist applicants in filling out an online form located on a centralized web portal developed by a nonprofit organization with CDSS funding. The selected organizations will deliver the assistance directly to qualified individuals. Based on their organizational capacity, nonprofit staff may use a variety of methods to provide outreach, application assistance, document verification, and assistance delivery. Staff may communicate with applicants telephonically, online (e.g. video conferencing), or in-person with proper physical distancing to ensure the health and safety of staff and applicants.

¹ Undocumented adults without social security numbers are ineligible for the federal CARES Act stimulus payments of up to \$1,200 per adult and \$500 for children under 16. Without work authorization, they are also ineligible for the \$600 federal augmentation to the weekly payments under the federal Pandemic Unemployment Assistance program. (See: [Understanding the Impact of Key Provisions of COVID-19 Relief Bills on Immigrant Communities](#), National Immigration Law Center, April 2020.)

² The total amount allocated for the Disaster Relief for Immigrants Project is \$79.8 million, including a new allocation of \$63.3 of Emergency Response for COVID-19 Response and \$16.5 million of Rapid Response Funds. The Rapid Response Fund was established in 2019 to award grants or contracts to entities that provide critical assistance to immigrants during times of need. Seventy-five million dollars will support direct assistance and an estimated \$4.8 million will support program administration through qualified nonprofit organizations.
