• Preliminary Budget Presentation

**Havlik:** Budget presentation. In June, we put the budget up for a vote to approve spending for next year. I'll present a preliminary budget for next yar. We are approx.. \$100,000 short now. But we have to get all of the Gala money recorded. We don't have the school budget now, I get it in June. That impacts this a little bit in terms of the asks that I make.

**HAvlik:** We've spent most of this money, but we will have some money to rollover into next year. We are approx.. \$100,000 short so far. In order to not take away from the kids now, we are reducing the amount set aside for TAs. Removing Robotics (was not a great program), and removing tech platform (we don't use SchoolLoop anymore). Where it's blue are where I've made reductions. It accounts for reduced funds that are raised. We could have fewer electives and lunch clubs next year. If we are one teacher short, we may not be able to offer as many electives. If we have to reduce TAs, we may not have as many teaching assistants. We will roll over some of the money we didn't spend this year on TAs.

We might have some problem meeting this next year. I think Heather and other board members might be talking about DA tonight, and that might be a place where this can come in.

I won't be here for the Q&A tonight, but I'll respond to emails tomorrow.

NEED CLARIFICATION: There is \$140,000 rolled over from prior years. (YES - \$140K)

Stacy Cole: Question, regarding if you don't meet that number, do you put them into something where more children benefit from those funds.

Havlik: Band and debate are the only two after school things that get funding. There may be ways to work with the vendors and see if the pricing might change. We may be able to work with vendors to reduce prices here and there, but they are such phenomenal programs that I wouldn't want to lose them

Marjorie: Q: clarify about electives, is that mostly the middle school grades, but what would that mean for the elementary school?

Havlik: Electives are mostly spent on the middle school kids, but we have been able to do some of them in 5<sup>th</sup> grade. The electives have been writing, sports electives, needlepoint. I would love to have a coding elective next year as an extension to what we give 4-5<sup>th</sup> graders now. There have been science based electives.

Heather: What's the difference between lunch clubs and electives?

Havlik: lunch clubs take place during lunch, like board games and Legos. Vs. Electives that are built into the school day, not during the school day.

Carlie: opens the floor to welcome any nominations for any of the positions.

Heather: We really need people in communications. I'm stepping down as co-president, but I'll be very involved. A plug for events – there will be people who can help you plan them and who'll be around to help you learn to plan an event.

Jane Diina: I'm Jane Diina, Lucy's mom (302), as a parent who is struggling for time as we all are, and what sold me was the sense of community that I felt at the Gala on Sat. and everyone has the same fears in terms of time, if you're on the fence, just do it.

Claire: Think about the nominations, you can nominate yourself after this meeting. The first time I got involved, it was as a parliamentarian. We need people on board by the end of this school year, but please think about it. It's not too late, we can do additional elections at the next meeting.

Marjorie: Your kids are watching and they see the work you're doing for their school and they can see your working hard for your school and it's important for your school and for them.

Brian: shows slides (see below)

He says we are doing pretty well compared with 2021. We are a little short. We are a little more than \$100,000 short, because we are about \$160,000 short because there are vendors we still have to pay. We have three accounts, 2 checking, one savings. We have to pay some vendors for the gala. June is our biggest fundraising month, hopefully we will continue that and chip into the \$160,00 shortfall. It helps if we can breach the gap, it's enormous.

**Marjorie:** Shows Shirley's video that was shown at the Gala, will be shown again here. We raised over \$45,000 for the Gala after we pay the expenses to throw the party.

### Heather: we are working out a deal to sell them at cost to sell the Journal.

**7:50pm SLT Report - Jeff Bolas:** 7<sup>th</sup> grade and 3<sup>rd</sup> grade. I'm an outgoing member of the SLT. There is one open position and it has to be filled. It's a mandatory position. The SLT is a mandated forum that every school is required to have where parents meet with admin, principals, and parents across middle and elementary school grades. Jeff explains what the SLT and how it works. We met over the summer in 2020 to see how BSI would handle the school year and it was instrumental in figuring out how BSI would operate n its hybrid year. Please run for the SLT and it's a two year commitment.

Recently, we lacked a quorum to meet in April. We are covered by bylaws, we need 5 parent reps. And so we need another parent rep. We are focused on generating a comprehensive educational plan that the school generates. (CHP) it lays out educational goals and quantitative ways to measure our progress toward those goals. It's data driven. At BSI, we don't have a lot of scrutiny of this document, but we looked at the iReady data instead. They are starting to provide longitudinal data about how students are performing in this teat against grade standards. We looked at iReady data and tried to understand the signals that data was giving us and see about a direction for the school. ELA, Math, Sped IEP and social and emotional learning. All SLT meetings are welcome to the public and you can attend. The next one is Tues., May 31, at 4:30 pm. The SLT is a lower time commitment position than a lot of other positions are. There are monthly meetings and your work involves a few hours a month and you know your schedule in advance.

Q: Tatiana: I won some auction items and how will the be distributed? I won some gift cards. There were a lot of more items this year and thanks for that. There are about 600 kids and only 40 people regularly participate in meetings. It would be a better idea to distribute everything – all of the slides and visual graphs shown at the meeting – it should be distributed to all parents who can read it at their leisure. Many people might not realize how imp. The meetings are. We need to be reminded about all of this information, and shown the video. We need to show more parents this so they are aware. I don't think that everyone understands that they are all members of the PTO. That message needs to be delivered to old and new parents alike.

Heather: I am in charge of distributing all of those items and I'm working down the list and connecting people to their item. I'll be in touch with everyone who won something. We are aware there are only about 40 people at the meetings. Visuals about the DA and such will be going out. Maybe we should backpack those materials too. It's good to hear these reminders and that we need to say it again and again. To remind everyone what the PTO does.
