<u>Digitized Sources for Global & American Research Projects</u> (updated May 2020)

A few important details about the below list:

- 1) It is not exhaustive, as it originates from a collaborative Twitter thread from November 2018 (https://twitter.com/sysgak/status/1062048149773127681). Nearly all of the collections from the thread are included here. Dates are included for the materials when possible, based off a quick glance at the website.
- 2) We must consider the context in which sources are selected to be digitized.
