Access Policy of the Ministry of Interior

SECTION 1.

The Ministry of the Interior, as the cornerstone of internal governance and security within the Empire, requires a robust and clearly defined access policy to safeguard its facilities, protect sensitive operations, and ensure the seamless execution of its mandates. This policy establishes a tiered framework to regulate entry into Ministry premises, balancing operational efficiency with stringent security protocols, in recognition of the Ministry's critical role during both wartime and peacetime.

- Command Staff of the Interior have unrestricted access.
- **Tier-1** grants unrestricted access to the Interior aside from the National Security Bureau wing to individuals explicitly listed under this classification.
- Tier-2 provides limited access, contingent upon the approval of the Interior Minister or Command Staff and successful security screening conducted by the Gendarmerie.
- **Tier-3** prohibits access entirely; individuals classified under this tier are barred from entering any Ministry facility.
- **Tier-X** designates access to an ultra-restricted area—specifically the National Security Bureau wing.

SECTION 2.

Command Staff of the Interior Ministry:

- Have full access to the Building
- The Command Staff are: Leading State Secretary of the Ministry of Interior, Chief of the Land Police, Chief of the Security Courts, Chief of the Gendarmerie and the Director of the National Security Bureau. They may remove anybody from the building as they wish unless otherwise specified.

Temporary Tier 1 Access may be granted by the following:

- The Interior Minister
- The Leading State Secretary
- The Deputy Chief of the German Police
- Interior Command Staff

Those granted Tier X Access to the Building:

- The National Security Bureau
- The Interior Minister
- Deputy Chief of Police
- Deputy of the Interior

Temporary Tier X Access may be granted by the following:

- The Director of the National Security Bureau
- The Interior Minister

Those granted Tier 1 Access to the Building:

- All Members of The Ministry of the Interior, the State Police, the National Security Bureau, Police Courts, Gendarmerie and German Red Cross.
- Ministers listed have honorary access that can be taken by any officer of the Interior:
 - o The Science Minister,
 - o The Truth Minister,
 - The Labor Minister.
 - o The Justice Minister,
- The Individuals listed below have preferred honorary status that only can be escorted off the premises on the orders of a member of command staff:
 - The Prime Minister with 4 guards,
 - The Grand Inquisitor with 2 inquisitors,
 - The Chairman of the Party,
 - The Finance Minister,
 - o The Procurements Minister,
 - o The State Minister with 2 guards,
- Up to 2 guests are permitted with entry of a member of the honorary list with explicit permission from a member of command.

Those granted Tier 2 Access to the Building:

- The Individuals listed below have Tier 2 access status that only can be escorted off the premises on the orders of any officer of the Interior and can only be permitted to enter by a member of command:
 - The Kriegsminister
 - Vice President
 - President
 - o The Aviation Minister
 - o The Foreign Affairs Minister
- Tier 2 members are not allowed to have guests unless permitted by the Interior Minister.

Those granted Tier 3 Access to the Building:

- The Individuals not listed above can be permitted to enter only by the Interior Minister, Deputy Chief of Police, Deputy of Interior, and the Director of the National Security Bureau.
- Trespassers are subject to arrest and/or lethal force in the event of a security threat
