

# Tox 2025 Commission ToS/FAQ

Please read the following information thoroughly to understand the full terms of service. This will help avoid any confusion later down the road and make this an easy experience for all parties involved!

## **Extra Fees.**

Please make note that the cost of your commission may go up depending on the details you add to the piece. If you request further detail or elements later in the commission stage, you will be sent an additional invoice for the cost of these extra items.

- Armor: base \$30 depending on complexity
- Extra heads/arms/limbs: case-by-case

## **What will you draw?**

I will draw *most* NSFW, furry, human, and some mech.

## **What will you *not* draw?**

I **do not** draw scat, vore, inflation, cub/shota/loli, hyper muscle/hyper genre overall, or R34 of certain characters. If you are unsure of what I will or will not draw, please ask.

## **What is the standard turnaround time?**

Standard turnaround is roughly 4-6 weeks for most work; a full and proper ETA will be given at the time of commission. Please be aware that these are **estimates** and I will try to meet these timelines as much as humanly possible, but a large queue, day-job hours, and other life events can extend the timeline. In all instances, I make great efforts to communicate if there will be a delay. Commissions with no deadline given from clients will be treated as “flexible” and the completion window will vary by 1-3 weeks if a piece with a deadline enters the queue. As mentioned before, clients will be notified of delays.

## **Messaging the Artist: When, Where and Why**

I love to talk with my clients! You guys are all super interesting and fun to talk to! However, it's become a common enough issue that unfortunately I have to add this into my ToS/FAQ. **Please do not message me unless it is in regards to the commission.**

## **Why is messaging you a problem?**

It usually isn't! The problem comes with folks who mean well clogging up my DMs with small talk suddenly and randomly. I will often reply thinking it's a polite attempt to inquire about a commission's status, but it usually turns into idle chatter that I really don't have the time to entertain, especially when a lot of these messages come in the middle of the work day. I have a full-time job I am often busy with and while I do love to chat, I can't spare the time. I'm sorry!

Also, I know we all have our bad days but please refrain from using my inbox as a shoulder to cry on if our only relationship is that of a client and artist. I genuinely feel for you but it's immensely unprofessional and inconsiderate. I am being paid to draw you something, not take the place of a therapist or friend.

## **Well, when is a good time?**

Messaging me any time on the weekend or after 5PM EST is often a good way to get a hold of me, again I ask that these messages only be about the commission though! I would much rather you be up front and about the work than have to figure out your sudden random 'how are you?/\*poke\*/yo' is casual chat or a polite inquiry.

## **Where should I message you?**

Always message me in the same message chain the commission was started on: A twitter DM, an e-mail, a discord DM, etc. Please **DO NOT** message me personally through discord if we were discussing your project elsewhere.

*Please* respect the personal/work boundary, moreso if you were not given explicit permission to message me there.

## **Messaging the Artist: Conclusion**

Please do not let these terms dissuade you from casually chatting with me publicly or on a server we may share. Like I said, I love to chat! I just genuinely cannot handle the frequency in which this has become an issue.

## Payment, Revisions and Refunds

I require payment up front for commissions; refunds are available, but the artist **keeps 40% for work completed**. Any changes beyond the first 24 hours of completion (after the client has agreed the piece is satisfactory) will be **\$20** per round of changes unless it is a glaring error on the artist's part.

**Paypal:** I will send you an invoice once provided with an e-mail address. Invoices are to be paid upon receipt or date listed on the invoice. If invoices are not paid by the agreed time window, your slot will be forfeited and you will be put on hold for up to 1 month before you may take another slot. ***I prefer PayPal for all transactions as it protects both myself as the seller and you as the buyer. Ko-fi handles all PayPal transactions on-site.***

## What can I do with this commission afterwards?

You can do whatever you like **PERSONALLY**. Crop it for an icon, print it for your wall, use it for a wallpaper, go nuts!

D&D Character comms: Absolutely feel free to crop for token art.

### However!

If you desire to use this artwork **commercially (Exclusions apply, see below)**, we will need to discuss this further.

## NFT & AI Policy

***Explicitly forbidden.***

I **do not** release rights to any clients—past, present, or future—to use any artwork they commission from me anywhere in the NFT or AI production cycle, hosting, process or network. This extends to any product involving blockchain/crypto/training/etc. in the past, present, or future.

Any clients found to be breaking this policy will be blacklisted from my client list and takedown notices will be filed for any instances of the work found on NFT hosting sites such as OpenSea and other similar platforms that deal in crypto, blockchain, and/or non-fungible tokens.
