## MERIAM IBRAHIM RELEASED, OTHER CHARGES PENDING

Meriam Yeyha Ibrahim, a Sudanese Christian and mother of two, was released from prison on 23 June after her sentence to flogging and death was reversed by an appeals court. She is now with her family in the United States Embassy in Khartoum but is unable to leave Sudan due to further charges against her. Meriam Yehya Ibrahim was sentenced to death by hanging for 'apostasy', and to flogging for 'adultery' on 15 May. Her case originated in August 2013 when she was charged with adultery, allegedly after relatives reported her to authorities for her marriage to a Christian man. Under Shari'a law as practised in Sudan, a Muslim woman is not permitted to marry a non-Muslim man, and any such marriage is considered adultery.

Meriam was detained in February after the court added the charge of apostasy when Meriam informed the court that she had been raised by her mother as an Orthodox Christian. On 11 May the court gave her three days to renounce her Christian faith or she would be sentenced to death, an option that Meriam rejected.

At the time of her trial Meriam was eight months pregnant. On 27 May she gave birth to her second child in the clinic of Omdurman Women's Prison where she was detained. Her 20-month-old son was detained with her.

Meriam's case attracted widespread international attention with over one million people responding to Amnesty International's appeal for her release. On 23 June she was released from prison after her sentence was overturned by an appeals court. The following day Meriam had intended to fly to the United States along with her two children and husband, who holds dual South Sudanese and American nationality. She was detained at Khartoum Airport by a group of 40 agents from the National Intelligence and Security Services (NISS) and taken into custody for questioning in relation to her travel documents. Her family accompanied her. On 25 June Meriam was charged with forgery and providing false information for attempting to travel with South Sudanese travel documents. Although the Embassy of South Sudan in Khartoum has asserted that the travel documents are genuine, the Sudanese Ministry of Foreign Affairs told Sudan's SUNA news agency that Meriam should have used a Sudanese passport. Meriam has been released on bail and is currently with her family at the United States Embassy in Khartoum. She is unable to leave Sudan until Sudanese authorities close this new case.

No further action is requested by the UA Network at this point. Amnesty International will continue to monitor Meriam Yeyha Ibrahim's case. Many thanks to all who sent appeals.

## FATHER OF MORSI'S AIDE RELEASED FROM PRISON

Adly al-Qazzaz was released in the early morning of 25 June after eight months in detention. He had suffered two heart attacks in detention and needed heart surgery.

The Public Prosecution had ordered Adly al-Qazzaz's release on "compassionate grounds", according to an official statement published in the Egyptian press. He is currently in al-Nile Badrawy Hospital in Cairo for a coronary bypass operation.

Adly al-Qazzaz's release was not believed to be conditional and he did not have to post bail. It is unclear if the Prosecution will continue with its investigation into his case. His family have thanked Amnesty International's members and supporters for their actions on his behalf.

Armed security forces arrested Adly al-Qazzaz at his home in Cairo in the early morning of 24 October 2013. He is the father of Khaled al-Qazzaz, an aide to deposed Egyptian president Mohamed Morsi who

has been detained since 3 July 2013. Amnesty International believes that it is likely that Adly al-Qazzaz was targeted because of his son.

Adly al-Qazzaz is in poor health. He suffered heart attacks in Tora Prison in February and May. Around a month ago he was transferred to al-Nile Badrawy, a private hospital, at his family's expense, but continued to be watched by the security forces until his release.

Since 3 July 2013, the security forces have arrested thousands of Mohamed Morsi's supporters, including most of the leadership of the Muslim Brotherhood.

# **COURT ACQUITS TWO MEN IN ZAMBIA**

On 3 July a Zambian court in Kapiri Mposhi acquitted two men charged with having sex "against the order of nature". The court ruled that the State had failed to prove the case against James Mwape and Philip Mubiana who had spent more than a year in remand prison awaiting trial.

James Mwape and Philip Mubiana were freed on 3 July after having been held for over a year in remand prison after their arrest on 5 May 2013. They were charged with having sex "against the order of nature" under Section 155 of the Zambian Penal Code. In terms of section 155 of the Penal Code, any person who (a) has carnal knowledge of any person against the order of nature; or (c) permits a male person to have carnal knowledge of him against the order of nature; commits a felony and is liable, upon conviction, to imprisonment for at least 15 years to life. The men denied the charges.

Both men were prisoners of conscience arrested solely on the basis of their real or perceived sexual orientation. In addition to Urgent Actions Amnesty International has worked together with local activists in Zambia to support the men in prison and to monitor the trial. The organization also lobbied the Zambian authorities to drop the charges against both men.

Freeing the two men is the right decision, but sadly it was reached for the wrong reasons. The Zambian authorities must fulfil their obligations to respect and protect all human rights and end the persecution of individuals on the basis of their real or perceived sexual orientation or gender identity.

## PRISONERS OF CONSCIENCE RELEASED IN MYANMAR

Prisoners of conscience Zaw Pe and Win Myint Hlaing have been released from prison in Myanmar after their jail sentences were reduced on appeal.

Zaw Pe (aka Thu Ya Thet Tin), a reporter for the media organization Democratic Voice of Burma (DVB), and Win Myint Hlaing were released from Thayet prison in Myanmar's Magwe region on 4 July 2014. The release came after a court in Magwe region reduced their prison sentences from one year to three months on 3 July 2014.

While Amnesty International welcomes the release of Zaw Pe and Win Myint Hlaing, they should not have been arrested and imprisoned in the first place. Both men were jailed on the pretext that they had committed a crime but in reality they were convicted and imprisoned solely because of their attempted criticism of the authorities. They were arrested in August 2012 after they tried to film an interview with an education department official in Magwe city, Magwe region about allegations of corruption. Despite their early release, Zaw Pe and Win Myint Hlaing have not been acquitted.

Many other prisoners of conscience – including journalists – remain jailed in Myanmar, and Amnesty International is demanding that they are all immediately and unconditionally released. The Myanmar

authorities must stop using oppressive legislation to punish peaceful dissent, or more people will continue to be imprisoned simply for peacefully exercising their human rights.

# **ANZOR CHENTIEV EXTRADITED TO RUSSIA**

Ethnic Chechen Anzor Chentiev, who was seeking asylum in Slovakia, has been extradited to Russia, where he might be at risk of torture and unfair trial.

The Slovak Ministry of Interior has confirmed that Anzor Chentiev was extradited to Russia on 6 July, as requested by the Russian Federation, approved by the Slovak Ministry of Justice. This is despite the fact that Anzor Chentiev had re-applied for asylum in Slovakia on 3 June.

The forcible return of Anzor Chentiev to Russia carried out while his asylum application was pending, amounts to a violation of Slovakia's international legal obligations. These include the obligation not to return anyone to a country where he or she would be at real risk of torture or ill-treatment or other serious human rights violations or abuses.

Anzor Chentiev had been detained without charge for nine years in Slovakia. According to his lawyer, this was due to the Russian Federation's extradition request, which was based on a charge of "banditry". No further action is requested from the UA network. # THREE ACTIVISTS RELEASED FROM DETENTION

Three Sudanese activists have been released after two months in detention without charge. Mohamed Salah Mohamed Abdelrahman, Moamar Musa Mohamed and Taj Alsir Jaafar were released from detention on 11 July. The three were detained by the National Intelligence and Security Service (NISS) outside the University of Khartoum on 12 May. All three are youth activists and were involved in protests at the University of Khartoum in late March after a student was shot dead by security forces at a demonstration on 11 March.

After their arrests, Moamar Musa Mohamed was taken to Kober prison, while Mohamed Salah Mohamed Abdelrahman and Taj Alsir Jaafar were held in the NISS detention facility in Bahri, Khartoum. Both Mohamed Salah Mohamed Abdelrahman and Taj Alsir Jaafar reported being subjected to ill-treatment during their detention. They were held in cells known as "the fridges", which are kept deliberately cold to make detainees feel uncomfortable. Both were also reportedly beaten, resulting in bruises on their bodies

and faces. Mohamed Salah Mohamed Abdelrahman is still struggling to see through his right eye. In late June Mohamed Salah Mohamed Abdelrahman and Taj Alsir Jaafar began a hunger strike, which, according to their parents, lasted three days before they were taken to a nearby hospital.

At no point were Mohamed Salah Mohamed Abdelrahman, Moamar Musa Mohamed or Taj Alsir Jaafar charged or granted access to a lawyer. The NISS rejected four applications by the families of Mohamed Salah Mohamed Abdelrahman and Taj Alsir Jaafar to visit them in detention, only allowing family members to briefly visit them on 13 June. The NISS twice refused to accept medication that Taj Alsir Jaafar's family tried to send him via the NISS office. Moamar Musa Mohamed's family did not manage to visit him while he was in detention.

During the week of 7 July the NISS informed the families of all three men that they would be detained without charge for further investigations for another three months, in line with Sudan's 2010 National Security Act. Four days later, on 11 July, the NISS released Moamar Musa Mohamed from Kober prison before releasing Mohamed Salah Mohamed Abdelrahman and Taj Alsir Jaafar that evening. No explanation was given for their release, although Mohamed Salah Mohamed Abdelrahman and Taj Alsir Jaafar were required to sign a pledge stating that they would not participate in or incite further demonstrations. Shortly after their release all three reunited with their friends and then returned to their families' homes.
