



- This serves as the ToS for all fursuit/mascot costume commissions including but not limited to: fursuit parts (heads, paws, tails, feet paws, or any other item which is considered part of a fursuit) fursuit construction parts (claws, foam bases, 3D printed bases, teeth, jawsets, 3D printed eyes or any other item used in the construction of fursuits) fursuit partials, fursuit fullsuits, fursuit refurbishments, and any other item used for fursuit cosplay. This ToS was last updated October 2024.
- I have the right to refuse or blacklist clients for any reason, especially if you in any way attempt to: defame, abuse, harass, stalk, threaten me or otherwise violate my rights or the rights of others. If I have blocked you on social media, you are immediately blacklisted. If you are blacklisted, you will NOT receive a refund on any work, and you will not be allowed to commission me for any project, and will likely be blocked from my social media.
- I have the right to refuse to create anything for any reason.
- You must be 18 years or older in order to commission me; if you are a minor seeking to get a fursuit from me, I must work through your parent or guardian. By the same token, because many children tend to outgrow clothes quickly, fullsuits may only be ordered for teens who are 16 years or older. I also will not sell any kind of suit to those under the age of 14.
- I can do:
 - Original Characters
 - Characters based off of pre-existing original species or media (i.e. Protogens, Dutch Angel Dragons, Pokemon, Khajiits, etc.)
 - Artistic Liberty Characters
 - Altering existing character designs you own
 - Altering existing suits you own

- Stylized suits (Kemono, Plush Suits, Toony Suits, Realistic Suits, etc.)
- NSFW Suits + suit parts/Murrsuits
- Suits that challenge my current skillsets (may be more expensive and take longer)
- I won't do:
 - Copyrighted/Branded Characters (Snoopy, Sly Cooper, Nick Wilde, etc.)
 - Replicating the styles of other makers
 - Replicating a specific artist's artstyle without that artist's permission
 - Characters you do not own the rights to
- 3/4ths suits & fullsuits require the making of a [duct tape dummy](#), which must be sent to me before I can start work on the bodysuit portion.
- If you seek to get an NSFW suit/murrsuit or otherwise want me to create or modify a suit for sexually explicit purposes, you may be subject to age verification. I will ask for a valid ID photo showing only your face and birthdate to verify your age, as well as a written keyword of my choice to ensure the photo is genuine.
- Please note I operate in a home with pets (a hypoallergenic dog and a cat). Although all pets are kept away from commissions, pets will be pets, and I cannot guarantee that your suit will not come in contact with an animal.
- All prices are in USD, and I only take PayPal.
- When you commission me, you will receive multiple PayPal invoices from me at different points during the commission process.
 - The first one is received after we have discussed the details for your suit and is the cost of materials. You must pay for the cost of materials upfront. If I do not receive the cost of materials, I cannot start the suit. This is nonrefundable under any circumstances.
 - The remaining balance will be sent once I receive the materials for the suit and can be incrementally paid off using PayPal's partial

payments feature. You may pay the balance while I work on the suit, however I will not accept the money until I complete your suit.

- The shipping will be charged as a separate invoice after I complete the suit and receive full payment.
- I will not provide the suit until full payment has been received. However, I can do payment plans, and should any financial emergency arise, I can hold onto the suit for up to 6 months with no payments.
- Do not try to ask for a refund or chargeback after you have received your suit.
- If you cancel a commission, please note I can not refund you if your suit is fully completed. I also ask that if you cancel, please be prepared to pay for whatever work I have completed.
- Refunds will only be given if you cancel the suit prior to its completion and have paid the full balance of the suit off. You will only be refunded for whatever I have not completed, and you will only be refunded if you are a customer who is in good standing and are not being blacklisted.
- I also have the right to resell whatever I have completed as a modified premade.
- If I feel I cannot complete your suit for whatever reason, I will refund you everything except the cost of materials.
- Once you pay cost of materials and the commission process has started, if you fail to respond to communication attempts within 90 days (or 3 months), I will issue a warning, asking you to respond within a week. If you do not respond or do not contact me on another platform, your commission will be canceled, and I will no longer work on it.
- If your commission is canceled due to a failure to respond to communication, you will have another 90 days (3 months) to contact me and provide a reasonable excuse as to why you did not respond. If not, I

will consider this ghosting, and you will be blacklisted and will not receive a refund for anything you have paid.

- I am not a full time fursuit maker. Because of this, I cannot guarantee my turnaround times are accurate. If you need your suits or parts for a specific convention, please provide the down payment for the suit at least 8-9 months in advance (4-5 for parts). It may take longer if I have a queue.
- I do not do rush orders, and my queue is first come, first serve. The code word to ensure you've read the ToS when filling out a quote sheet is blue.
- I offer free repairs/small modifications on my suits/parts for the life of the item, and if you find a defect with the suit within the first month of receiving it, you will not have to pay shipping to get it fixed. Otherwise you must cover shipping for free suit repairs/modifications. If your suit is used for any form of adult activity, it must be *sanitized* (thoroughly washed with soap, water & alcohol) before I receive it. I have the right to deny suit repairs if I feel the suit was intentionally mishandled or broken. I also encourage customers to learn how to sew in order to fix small rips and tears ([see this playlist for info on how to care for suits!](#)).
- I also offer discounted refurbishments, large modifications, and fursuit deep cleans (for sfw suits only) at 25% off the normal price.
- If for whatever reason you need to ship me an item relating to a commission (duct tape dummy, a suit for repair, a suit being sent for refurbishment, etc.) please note I do not cover the cost of shipping unless I state otherwise.
- All partial suits and full suits automatically come with a wire brush, fursuit spray, a fursuit repair kit, laminated character badge, and a sticker. If for whatever reason you do not want these items, please let me know before I ship the suit.
