INTRODUCTION

The manuscript should be between 4,000 and 8,000 words in length, inclusive of all components. Authors are required to conduct thorough grammar checks and proofreading prior to submission to ensure the article is well-structured, coherent, and easy to follow. Do not include any headers, footers, or page numbers, as these will be added by the STAIRS editorial team.

The Introduction section should constitute 15–20% of the total article length. It should provide a comprehensive background, including a review of relevant literature and previous studies, an identification of research gaps or novelties, the problem(s) addressed, the study objectives, and the significance of the research. Clear articulation of these elements will establish the context and rationale for the study.

RESEARCH METHOD

The Research Method section should comprise 10–15% of the total article length. It should provide a detailed description of the research design, data and data sources, data collection procedures, and data analysis techniques. Clear and systematic presentation of these elements is essential to ensure the research process is transparent and replicable.

RESULTS AND DISCUSSION

The Results and Discussion section should constitute 40–60% of the total article length. A combined Results and Discussion format is acceptable. Highlight the differences between your findings and those from previous studies but avoid extensive citations or lengthy discussions of published literature. If subsections are required, they should adhere to the following format.

or simply listing the results. Instead, emphasize potential applications, extensions of the study, and suggestions for future research.

ACKNOWLEDGEMENT (Optional)

The Acknowledgment section recognizes individuals and organizations that contributed to the research, particularly **funding** agencies and those who provided significant assistance. Authors should not include themselves in this section. It should comprise 5–10% of the total article length.
