

**Outcome document of the High-level Meeting of the General Assembly: The World Conference on Indigenous Peoples**  
**Compilation of remarks made on the revised version of 29 August 2014.**

1. We, the Heads of State and Government, Ministers and representatives of Member States, reaffirming our solemn commitment to the purposes and principles of the United Nations Charter, in a spirit of cooperation with the Indigenous Peoples of the world are assembled at United Nations Headquarters in New York on 22 and 23 September 2014, on the occasion of the World Conference on Indigenous Peoples, to reiterate the important and continuing role of the United Nations in promoting and protecting the rights of Indigenous peoples.	
2. We welcome the indigenous peoples' preparatory processes for the World Conference including the Global Indigenous Preparatory Conference for the World Conference on Indigenous Peoples held in Alta, Norway, in June 2013. We take note of the outcome document of the Alta Conference <sup>1</sup> and other contributions made by indigenous peoples. In addition to the Declaration, we recall the other major achievements of the past two decades in building an international framework for the advancement of the rights and aspirations of the world's indigenous peoples, including the establishment of the Permanent Forum on Indigenous Issues, the creation of an Expert Mechanism on the Rights of Indigenous Peoples, and the appointment of a Special Rapporteur on the Rights of Indigenous Peoples.
