Macomb County Community Services Agency

Macomb County Community Services Agency has three Community Action Centers. The Community Action Centers offer support services to income eligible families, individuals, senior citizens and disabled persons with

the goal of improved self-sufficiency. The Community Action Centers also serve as an intake point for other MCCSA services. The Community Action Centers provide information and referrals for many human service needs. If you have general questions regarding the Community Action Centers call 586-469-5222. If you are seeking assistance, contact the Community Action Center in your area.

Emergency Assistance: Utility Help

Income eligible Macomb County residents facing utility shut off may be assisted in resolving their emergency. Utility assistance may be available for electric service, natural gas service, and water service. Assistance with deliverable fuels used to heat the home such as home heating oil, propane, wood may also be available. Eligibility and guidelines will vary based on available programs. Macomb County residents seeking utility assistance are seen by appointment only at the Community Action Center offices. Documentation for program eligibility is required. Contact your Community Action Center for more information about utility assistance.

Emergency Assistance: Rent/Mortgage Help

Income eligible Macomb County residents facing eviction or foreclosure may be assisted in resolving their housing emergency. Eligibility and guidelines will vary based on available programs. Macomb County residents seeking rent/mortgage assistance are seen by appointment only at the Community Action Center offices. Documentation for program eligibility is required. Contact your Community Action Center for more information about rent/mortgage assistance.

Tax Preparation

Income eligible Macomb County residents may be assisted with free income tax preparation and filing. MCCSA's Community Action Centers are IRS Volunteer Income Tax Assistance (VITA) sites. Macomb County residents seeking tax preparation assistance are seen by appointment only at the Community Action Center offices. Documentation for program eligibility is required. Contact your Community Action Center for more information about tax preparation assistance.

Weatherization Program Registration

The Community Action Centers complete applications for MCCSA's Home Preservation/Energy <u>Weatherization</u> <u>program.</u> Macomb County residents applying for the Weatherization program are seen by appointment only at the Community Action Center offices. Documentation for program eligibility is required.

Supplemental Food Programs Registration

The Community Action Centers register eligible Macomb County residents for two supplemental food programs to help households stretch their food budgets. Registration is available for:

- Commodity food/TEFAP(The Emergency Food Assistance Program)*
- Focus: HOPE food for seniors (CSFP Commodity Supplemental Food Program)

Contact your Community Action Center for more information about supplemental food programs.

If You Need Food

The criteria to access the Macomb Food Program requires only that a person be a Macomb County resident and have an emergency need for food. The person in need of emergency food must call United Way information/referral **2-1-1** (or 1-800-552-1183) or contact us at 586 469-6004.

Transportation

MCCSA's Transportation program provides transportation to essential medical appointments and other specific locations for eligible Macomb County residents. Services are also provided in coordination with MCCSA's other programs such as Head Start and Meals on Wheels.

Program Guidelines

Individuals interested in transportation services must meet program eligibility guidelines.

- Must be a Macomb County resident
- Must meet Community Services Block Grant income guidelines
- Must complete an application for service at a designated Community Action Center
- Must have a documented need for medical treatments
- Does not have access to public transportation (SMART or municipal services)
- Does not live with someone who owns and drives a vehicle
- A caregiver must assist any rider who is unable to meet the vehicle curbside without assistance

Making a Request

- Requests for transportation must be made during regular business hours: Monday Friday, 8:30 a.m. 5 p.m.
- Transportation operates between the hours of 6 a.m. 4:30 p.m. Riders must depart for their final destination by 2 p.m.
- Requests for rides must be scheduled at least one week in advance of the needed service, two weeks advance notice is suggested.
- 24 hours advance notice is required to cancel a ride.
- Trips are primarily limited to destinations in Macomb County.

Wheelchair Equipped

MCCSA has vehicles designed to accommodate people who use wheelchairs. Hydraulic lifts allow frail or physically challenged people to be transported in their wheelchairs.
