Executive Summary of the Cyclical Program Review

Review Team

Since the CPR coincided with accreditation, the Review team consisted of the Canadian Architectural Certification Board (CACB) Visiting Team of five voting and one non-voting members.

Program strengths, weaknesses and opportunities as identified in the External Reviewer's Report

The Visiting Team Report (VTR) outlined areas of excellence and areas of concern with respect to "Conditions" and "Performance Criteria". Under "Section 2 Conditions for Accreditation 'met' and 'not met'", of the 11 conditions, nine were met (#1. Program self-assessment, #2. Public information, #3. Equity-Diversity and Inclusion, #4. Student Composition, well-being and enrichment, #6. Space and technology resources, #7. Information resources, #8. Financial resources, #9. Administrative structure, #10. Professional degrees and curriculum), one was not met (#5. Faculty and Staff Resources) and one included detailed concerns (#11. Performance Criteria).

Review Team's Assessment

Present the review team's overall assessment of the program

The CACB Visiting Team noted the following strengths of the program:

- Program's vision, mission, and strategic plan are still "ambitious, relevant, inclusive [...] its tricultural mandate and instruction in both English and French, commitment to a design-build culture, and integrated Co-op Program, set the table for curricular excellence and a generous and robust student experience" (2018 Visiting Team Report (VTR), 7).

- The Program is “grounded in the culture, landscape, and social fabric of Sudbury and Northern Ontario” (2018 VTR, 8). In this respect, it is greatly contributing to the community and to the redevelopment of downtown Sudbury. It also has successfully integrated into the community with design-build projects, by inviting the community into the building, and by sharing ideas and space.
- The student body is “fundamentally invested in the vision of the Program and cite numerous advantages of being a student at the MSoA. The students chose the Program based on its commitment to environmental stewardship, design-build opportunities, the Co-op Program”, and travel opportunities (2018 VTR, 8). As well, students are enthusiastic, very engaged, and have full confidence in their faculty.
- The support staff are extremely dedicated to the Program, very often going out of their way to help and support the faculty and the students.
- The faculty have demonstrated dedication to MSoA and many have earned tenure and promotion, as well acclaim in federally funded research, teaching awards and publications. They are truly committed to the uniqueness of the Program, its growth and development, as well as the students’ wellbeing. Challenges and opportunities ahead will surely motivate them.
- The MSoA’s building is magnificent and one of the finest examples of sustainable design on Canadian campuses. It is acclaimed as one of the top 15 facilities for architecture schools in the world:
