

Safe Environment Guide

Thank you for your willingness to be a partner in ministry! Our parish simply could not offer so many ministries and opportunities to catechize, evangelize, and support young people without your service, dedication, and generosity.

All of our efforts to provide a safe environment help our young people to become disciples of Jesus Christ. The safe environment policies and standards of the Diocese of Cleveland are in place to protect God's children in our Catholic parishes, schools, and other organizations.

They reflect the principles outlined by the United States Conference of Catholic Bishops' Charter for the Protection of Children & Young People as applied in the Diocese of Cleveland.

Every year, our parish must audit local records and report compliance with the <u>USCCB Charter for the Protection of Children and Young People</u> and <u>diocesan expectations</u>.

If you are a parish volunteer or employee who will be around minors under age 18 (1) more than once a month, or (2) more than 4 hours per month, the following steps are required before you begin your service.

We know this process can seem burdensome, but most of these tasks are one-time only. This guide will help you achieve and maintain active status as a volunteer who works with children and youth.

Steps to Compliance

1 - Virtus Session & Training Bulletins

Attend a Virtus "Protecting God's Children" Awareness Session

This is an important step because compliance is tracked through the Virtus database.

This training conducted by VIRTUS® certified facilitators is about the prevention of child sexual abuse. The training makes participants aware of the signs of child sexual abuse, the methods and means by which offenders commit abuse, and five easy steps one can use to prevent child sexual abuse.

This workshop is offered throughout the Diocese of Cleveland. To attend you will need to create a Virtus account and register for the session at www.virtus.org.

Click the "First-time registrant" button on the left-hand side to create an account, or log in with your user ID and password if you previously created an account.

Then select "Cleveland, OH (Diocese)" in the drop-down menu.

Virtus Training Bulletins

You will receive an email from Virtus every month with a prompt to read the latest bulletin. Each bulletin has a question at the end. When you answer the question correctly the Virtus database logs the training bulletin as completed. Please keep your account updated with a current and working email address.

For those without internet access, a binder with 25 training bulletins is available from the parish Virtus Administrator.

3 - Background Check

You will need to obtain a background check.

OPTION 1 - You can obtain your initial background check prior to beginning your service as a volunteer through one of the providers/locations listed below.

This initial background check is good for five years. On the fifth anniversary of this background check, you will receive a prompt when you log into your Virtus account to register with Selection.com (see OPTION 2).

An initial background check through Ohio BCI is sufficient for those who have been a resident of Ohio for the past five years.

Residents of Ohio for less than five years are required to obtain a background check through the FBI.

For a background check you will need your driver's license or state ID & social security number.

Please note: BCI "Reason for Fingerprint" Code would be:

NO ORC Other: "teaching PSR" or "coaching CYO" the role for which you Volunteer.

As soon as these are received by the parish Virtus administrator, they will be recorded in your Virtus account.

OPTION 2 - To avoid the need for a repeat background check in five years, you can log into your Virtus account, click on the TOOLBOX tab, and then the link in the navigation bar Selection.com Background Check. This will be linked with your Virtus account and is a one-time background check option. There is a \$25 fee payable online at the time of registration with Selection.com

Selection.com is a safe and secure website that provides background check services to companies and non-profit organizations for their purposes of vetting potential hires and volunteers. The system will automatically run a check using your SSN every 3 months. Once you have enrolled yourself into the program, Selection.com will run a check for you and all of our staff and

volunteers every 3 months to see if there are any incidents that would affect your ability to work with children. The checks performed are designed to only bring up those incidents that directly pertain to working with minors, so the parish will not see "everything you've ever done". The parish will not enter your Social Security number into Selection.com; you will. The parish will not be handling your Social Security number at any point.

On-going background checks are the best way to continuously ensure that only responsible persons are serving our young people. The Diocese of Cleveland is employing both of these methods: initial fingerprinting (through BCI and/or FBI and recurring Social Security number scans through criminal databases in the Selection.com system.

In <u>Lorain County</u>, call Lorain County Children Services Board - 440-329-5340. After business hours 440-329-2121.

In <u>Cuyahoga County</u>, call Cuyahoga County Department of Children and Family Services – 216-696-KIDS (5437).

If you suspect child sexual abuse within the Diocese of Cleveland, call the 24 hour response line AFTER you call civil authorities 216-334-2999.
