

# Riverside Sheriff Accountability Coalition \*UPDATED\* Action Toolkit

**RSAC** is a group of Riverside County residents and organizations that continues to call on our Riverside County Board of Supervisors to ensure transparency, accountability, and justice within the Riverside County Sheriff's Department (RCSD.) On **July 29th**, **2025**, Supervisor Medina introduced a vote that would have created an ad-hoc commission to study civilian oversight of the sheriff's department.

Unfortunately, the rest of the Board of Supervisors was too cowardly to back up Supervisor Medina and showed us their true colors. Supervisor Perez, Gutierrez and Washington care more about the donations they receive from the Riverside Sheriff's Association than their constituents and those who have been harmed by RCSD.

Join us in continuing to ask for oversight and to let them know that our community is not only frustrated at their lack of action but will hold them accountable for their indecisions.
