Together with the representative from Supervisor Williams office (Kat),
Rayshawnda shared positive outcomes of the day. The total dollar figure was less
than anticipated; our contribution will be approximately \$2,475.00. Co-chair
Nguyen then asked for comments from all those present who had attended and
solicited suggestions for the future of this important program. Among the
suggestions was that we should reach out to teen moms in an intentional
manner. Commission Madison suggested we have at least four commissioners
involved in the planning of the event next year. Many wonderful resources were
there in the form of vendors and in give-aways such as diapers and pack and go
play sets. Many special conversations were had one on one with Moms, Dads etc.

Solano Commission For Women And Girls Girls on the Rise (Commissioner Hamilton) Commissioner Hamilton and others who have been involved with Girls on the Rise unanimously recommended that we continue to support this event, now in its second season and founded by members of the Superior Court Justices and The Solano County Bar Association. As was the case with Birth Justice, more support from members of the Commission was requested, particularly on the day of the event. This year the event went beyond introducing attendees to law professions to include panelists from other professions. It was well attended and planned. Event was Hosted by Supervisor Vasquez. - 7. Update: You Matter. Period Program (Commissioners Srinivasan and Mashburn)

Commissioner Srinivasan shared an excellent and informative power point presentation of the proposal she and Commission Mashburn have been working on. The focus thus far has been mostly focused on working in the schools to have at least one classroom teacher in each middle and high school willing to have a period basket in her room and one youth willing to be the representative to Commissioner Srinivasa's organization to ensure that the basket is kept refilled with supplies etc. There will also be a period packing day at Solano College in the offices of the organization to put together as many packets as possible to be distributed not only to schools but to other organizations serving women and girls in need in Solano County. A large budget already exists from an earlier grant but there will also be ways to contribute through QR codes. Commissioners Srinivasan and Mashburn are putting together a comprehensive list of items needed. Commissioners Madison, Galo. Eckhoff and Brumfield all volunteered are to be available to our youth commissioners in the planning process as needed.
